



The Ballyogan Regional Temporary Rest Centre opened its doors to Ukrainian nationals on 28 April. The Rest Centre continues to accommodate up to 300 displaced Ukrainian nationals for short periods. Over 3,000 people have stayed at the centre for short periods.

As part of a comprehensive wrap around service, accommodation services at the Centre are being supported by HSE staff including Environmental Health, Public Health and COVID-19 services. The HSE is providing onsite support to meet the healthcare needs of Ukrainian residents, and residents also have access to an offsite GP service 7 days a week.

Among the facilities available in the temporary rest centre is separate laundry and sanitary facilities, internet access, television spaces, games consoles, games room, chessboards, use of bikes and scooters, libraries of Ukrainian books for children and adults, translation services, as well as online access to Ukrainian newspapers and magazines.

Additionally, orientation and information sessions, basic English language lessons and an arts and music entertainment programme is being developed both onsite and nearby offsite.

Local coordination efforts continue to provide comprehensive support services from Southside Partnership, HSE, An Garda Siochána, Department of Social Protection, dlr Education and Training Board, TUSLA, Community and Family Resource Centres, dlr Volunteers Centre, colleagues in the East Region and a number of other community and voluntary groups.

Work is now underway to provide extra facilities, including 92 extra beds, a homework club room for children, an adults workspace, and a new improved space for teenagers.

# **Road Safety, Cycling and Sustainable Travel**

Launch of the Road Safety Strategy plan for 2023-2030. Councillors and members of SPC invited on 27<sup>th</sup> of January 2023. Staff and CEO attended.

Started recruitment of new intake of School Wardens. Letters were issued for refresher training.

#### **Speed Limit Review**

Public consultation documents are currently being prepared.

#### **Traffic Advisory Group (TAG)**

A Tag meeting took place on  $18^{th}$  of January 2023 in Area 1 – Dun Laoghaire, and 23 items were dealt with. A Tag meeting also took place on the  $31^{st}$  of January 2023 with 15 items dealt in Area 2- Dundrum.

#### **Bus Connects**

The Traffic Section, with cross departmental input, made a submission to ABP with respect to the proposed CBC. ABP has advised that the decision due date for this planning application, has been put back to before April 7<sup>th</sup>,2023. Regarding the Bray to City Centre CBC planning application, the NTA has advised that the submission of this application to ABP is now envisaged in Q1, 2023.

# Bus Interchanges at Dundrum, Dun Laoghaire & Blackrock

Discussions are ongoing with the NTA regarding bus interchange improvements at both Dundrum and Dun Laoghaire. The improvements are needed to cater for the planned service increases under the BusConnects' programme. Meetings/workshops are ongoing to progress this work and a multi-disciplinary group from the Council is in place to assist.



In addition, discussions are also ongoing with the NTA regarding potential public realm improvements in Blackrock and the impact on the existing bus interchange and bus services.

# **Area Based Transport Assessments (ABTAs)**

**Dundrum ABTA -** Work on this project is progressing and the ABTAs Stages 1 & 2 now completed with work on Stage 3 – Options Assessment & Development and Stage 4 - Preparation of a draft Local Transport Plan, now at an advanced stage.

Racecourse South lands & Kilternan - Glenamuck – The Council, in conjunction with the NTA, is progressing Area Based Transport Assessments (ABTAs) for the Racecourse South lands at Carrickmines, in accordance with the requirements of SLO 143 in the current County Development Plan and for the Kilternan – Glenamuck area in order to support the preparation of a Local Area Plan to replace the current Kilternan – Glenamuck Local Area Plan, due to expire later this year. The Council is aiming to have a consultant appointed in Q2 to commence the studies.

# 3. Water & Drainage

#### **Drainage and Flood Alleviation**

Engineering and Environmental Consultants were appointed in December 2019 for Flood Risk Management works on the Deansgrange Stream. This is a 4-to-5-year project. Activities completed to date include additional survey work, CCTV surveys, a Constraints Study, Hydrological analysis, and hydraulic modelling. Optioneering, environmental surveys and engagement with key stakeholders are underway. A Ground Investigation Contract is complete, and the report is awaited. Work has begun to review sites for environmental impacts. We have received preliminary approval from Irish Rail to tunnel under the rail line. Public Consultation on the preferred option took place on the 13<sup>th</sup> December. Detailed preparation is beginning for the Part 8 submission.

Engineering and Environmental Consultants have also been appointed for Flood Risk Management Works on the Carrickmines/Shanganagh Rivers. This is a 5+ year project. Data gathering is underway. A Flow/Rainfall Survey is complete. Further topographical survey work has been done. Early damage/benefits assessments are underway to ensure a cost-beneficial scheme is achievable. An initial public engagement is complete following short briefing sessions with Area Councillors. The Hydrology/Hydraulic report is now complete and initial options are being developed. A Contractor was appointed for the Site Investigation. The on-site SI work is largely completed. The Contractor must now process the information.

The Monkstown environs flood risk mapping project is underway. The topographical survey is now largely completed. The flow/rainfall survey is now completed, and the CCTV survey is well underway. Draft flood maps have been produced and reviewed. The consultant is also looking at some options to help relieve potential flooding in the catchment.

#### Cleansing, Beaches & Coastal Protection Updates

- Coliemore Harbour: Coliemore Harbour rock anchor installation and structural repair project is scheduled to commence in March. Final details are being reviewed and agreed with the contractor. It is expected that the project will take approximately 8 weeks to complete.
- Quinns Road The beach access repair works were tendered, and a contractor has been selected. Access and compound conditions are under review and Local Councillor and Resident Group communications will be commence within the next few weeks. The contractor is expected to start in early March. Access onto the beach from Quinns Road will be prohibited during the 8-week construction period.
- 40 Foot Remedial Repairs One ladder has been installed thus far and the remaining elements of the project will be completed during February and March. Long lead times for wrought iron and fabrication time have caused the project to be delayed thus far.
- Public Realm cleaning is on-going presently with power washing and furniture cleaning.
- DLR Baths Maintenance crews are in place at the Baths and daily cleaning is underway to remove washed up seaweed, stones, sand etc. whilst also emptying bins
- The Road and Cycle Lane Sweeping schedule has remained suspended for January to enable CRMs and other work areas to be swept. The Sweeping Schedule will be reinstated from the 1<sup>st</sup> of February.
- Gully Cleaning operations and early morning works are on-going.
- An advert for Beach Lifeguards was posted on the 26<sup>th</sup> of January.
- Bathing water sampling is ongoing at our 9 locations every fortnight as scheduled

# 7. Dún Laoghaire Harbour

#### **Cruise Ship Business**

We had approximately 72 Cruise Ships booked into the Harbour in 2022. 3 ships cancelled due to weather. Overall, the Harbour was being well received by ship management, cruise guests and the crew who come ashore. We are now doing a full review of the 2022 season with our various stakeholders and beginning to plan for a busier 2023 season with approximately 90 ships booked at present.

#### **Grant Funding**

The Brexit Adjustment: Local Authority Marine Infrastructure Scheme 2022 – 2023 from the Department of Agriculture, Food and the Marine has launched a Second Tranche call for applications. Dun Laoghaire Harbour received over €3 million in grant funding from the first tranche. We submitted 5 grant applications to this scheme by the deadline of  $30^{th}$  September 2022 and have been awarded another €1 million in grant funding for improvements on the Carlisle Pier.

#### **Projects:**

#### **National Watersports Campus**

DLRCC in partnership with Irish Sailing and the Irish Underwater Council have been approved in principle for Stream 1 Grant funding for the development of a National Watersports Campus. We have responded to requests for additional information and are now finalising the grant process and agreements with the project partners. An MOU has been signed with Irish Sailing and Diving Ireland in order to set out and agree the objectives of the project.

DLRCC and Irish Sailing are developing a brochure/prospectus for the project to detail the project vision and scope. It is hoped that this initiative will assist in building momentum and support for the project. This document will be presented to councilors in February 2023.

#### **Berth 2 Fenders (Carlisle Pier)**

A project to replace the Berth 2 fenders has been given approval to proceed to procurement stage. RPS Group have been appointed to carry out the design and procurement for this project. This project was tendered, and Sorensen Construction have been appointed to deliver the project. We are awaiting Foreshore consent to proceed to



works on site.

Grant funding has recently been secured for the installation phase of this project from the recent Brexit Local Authority Marine Infrastructure Scheme.

# **Berth 3 Fenders (Carlisle Pier)**

Grant funding has recently been secured for a project to replace the Berth 3 fenders from the recent Brexit Local Authority Marine Infrastructure Scheme. The project has been given approval to proceed to procurement stage. RPS Group have been appointed to carry out the design and procurement for this project as it is a mirror image of the Berth 2 fender project.

# **Carlisle Pier Deck repairs and lighting**

Grant funding has recently been secured for a project to resurface the deck of the Carlisle Pier and install lighting towers from the recent Brexit Local Authority Marine Infrastructure Scheme. This project is now out to tender.

#### **East Pier Revetment Repairs**

Grant funding has recently been secured for a project to repair the sloping revetment at the back (east side) of the East Pier from the recent Brexit Local Authority Marine Infrastructure Scheme. This revertant provides the primary protection for the East Pier and has suffered some damage over recent years from the larger storms. Punch Consulting Engineers have been appointed to design and manage the project which is likely to be on site during the summer of 2023. Surveys are now complete, and design work is well underway on the repair project.

#### **Ferry Terminal**

Planning permission was granted for the ferry terminal project on 7<sup>th</sup> February 2020. A planning appeal was lodged to An Bord Pleanála. An Bord Pleanála have now granted permission for the development.

A business briefing on the ferry terminal proposal was delivered to the elected members by Hilary Haydon on 25<sup>th</sup> February 2020. An agreement to lease the building (subject to Foreshore and Section 183 consent) was signed in December 2021, and the Foreshore Lease has been agreed with the Dept.

This matter was brought to the full June Council Meeting and the Section 183 Disposal passed and the lease granted on 5<sup>th</sup> July 2022.

#### **Dublin Array Windfarm**

The developers of the Dublin Array Windfarm have approached the Harbour about the possibility of establishing an Operations and Maintenance Base for the windfarm. It is hoped that there might be synergies with the Ferry Terminal project. Early engagement is ongoing with the developer's team to establish the exact requirements.

#### **Coastival Festival 2023**

The Biennial Dun Laoghaire Regatta is due to take place in July 2023. We are working with several DLRCC departments to expand this into a week-long festival names "Coastival" for the Dun Laoghaire Town and Harbour areas. This is planned to run from  $1^{\rm st}-9^{\rm th}$  July and many DLRCC departments are involved in putting together a schedule of events.

#### **Community Response Forum**

The Community response to the crisis in Ukraine and the influx of Ukrainian nationals into the county is being led and coordinated by Dún Laoghaire-Rathdown County Council in collaboration with a wide range of stakeholders in the Community Response Forum, supported by a wide range of community and volunteer groups.

The Community Response Forum has been meeting since 28 March 2022 and met three times during January. Support services are being provided to those Ukrainian nationals who are being accommodated in the Ballyogan Rest Centre and Larch Hill Scout Centre as well as in hotels and in private accommodation within the County.

English classes and other activities continue to be provided in Ballyogan, Sandyford, Dundrum and Loughlinstown. English classes are also being provided in libraries. Employment support services are being organised by Southside Partnership.

# The Hall School 150 Level 3, dlr LexIcon Until 14 Jan 2023

Memories and memorabilia from the Hall School Monkstown to mark 150 years since it was founded in 1872. Younger visitors can try on the replica hat and dresses, while everyone should enjoy the wide range of photographs, artefacts and memories of schooldays gone but never forgotten. In 1973, the Hall School amalgamated with Park House and Hillcourt, creating Rathdown School.

From their origins as a private enterprise, through the Edwardian redevelopment by the Urban District Council and covering heydays and dereliction through to the present day. It charts the highs and lows of this much-loved local institution – swimming lessons, sunbathing paradise, childhood freedom, protests, ice creams and fun park. Told through the images and the voices of those who lived, worked and played in the Dún Laoghaire Baths over many years, the exhibition brings the past to life, while looking to the next chapter in the life of this iconic Dún Laoghaire attraction.

# Christians in Morocco: Living Together Level, dlr LexIcon Until 28 February

This exhibition shines a spotlight on some episodes in the shared history of religious groups in Morocco, tracing the 800-year history of the Christian community there, including the visits of Pope John Paul II in 1985 and Pope Francis in 2019.
