#### **Welcome and Introductions**

Cllr. Smyth welcomed everyone. Apologies were noted.

## Minutes and matters arising

The minutes of the meeting held on the  $15^{th}$  February 2022 were proposed by ClIr Grainger, seconded by ClIr O' Connor and agreed by the Committee.

## Ministerial/Departmental/Other Correspondence

It was noted that there was no business to discuss under this heading.

#### **LA16 Collision Reporting**

Gerry Flaherty, Senior Executive Engineer, Traffic and Road Safety Section, gave a brief presentation on road collision data from the RSA. It was noted that there were 3 fatal collisions in recent months in the County and a summary of the fatal collisions was outlined. It was also noted that work has commenced on the preparation of a new Road Safety Plan 2022 to 2030 and the Council is seeking feedback from individuals, groups and key agencies on what actions should be contained in the Road Safety Plan.

Following the presentation, a brief discussion took place during which Gerry Flaherty responded to queries.

# **Local Policing Fora Reports**

Ian Smalley presented the main points of the Local Policing Fora reports for Central Dún Laoghaire LPF, Shankill/Ballybrack/Loughlinstown LPF, Sandyford/Stepaside LPF and Dundrum/Stillorgan LPF. Each report was circulated to the members prior to the meeting.

Following the presentation, a brief discussion was held, and queries were raised in relation to the issue of rogue traders, speeding in estates, cycling on footpaths, parking on footpaths, and double yellow lines, seizures of scrambler bikes in Kilbogget Park. Members acknowledged the work of An Garda Síochána in relation to Kilbogget/Coolevin and Ashlawn estates and in relation to the Operation at Shankill Dart Station.

## **DLR Joint Policing Committee Workplan Updates**

Mary Ruane presented the JPC Workplan updates. Following the presentation, a query was raised about support for victims of crime. Chief Superintendent Nyland replied and advised that further details would be provided in the Presentation on Victim Support to the Public Meeting.

Chief Superintendent Nyland gave a presentation which included the following areas:

- Outline of Divisional Protective Services Unit
- Operation Irene 2022
- DMR East Divisional Drugs statistics (1<sup>st</sup> January- 20<sup>th</sup> May 2022)
- Breakdown of Crime Statistics April 2021/2022
- Breakdown of Roads Policing Statistics January April 2020-2022 (comparison year on year)

Following the presentation, the Chair invited questions from the members. Queries/comments were raised by members and responded to including enforcement against cyclists, gender balance in the Division, statistics on drug seizures. Cllr Grainger asked if a copy of the presentations could be forwarded to the committee. Tony McCarthy congratulated An Garda Síochána on their centenary. Cllr Donnelly expressed concern over the way victims are treated in the justice system.

Following a discussion, Chief Superintendent Nyland responded to the queries raised and the committee thanked him for the report and for the work of An Garda Síochána.

- Cases of spiking in bars, night clubs and other venues as outlined in S6, S8 and S12 and other sections of the Non-Fatal Offences against the Person Act, 1997 – Statistics for years: 2021, 2022 (to date)
