





Drainage & Flood Alleviation

Engineering and environmental consultants were appointed in December 2019 for Flood Risk Management Works on the Deansgrange Stream. Activities completed to date include additional survey work, CCTV surveys, a constraints study, hydrological analysis, and hydraulic modelling. Optioneering, environmental surveys and engagement with key stakeholders continue. A Ground Investigation Contract is complete. We have received preliminary approval from Irish Rail to tunnel under the rail line. Public consultation for the Part 8 Planning process on the proposed scheme ended in August. The Chief Executive report for the Part 8 is now being prepared and will be brought to the December Council Meeting.

Engineering and environmental consultants have also been appointed for Flood Risk Management Works on the Carrickmines/Shanganagh Rivers. Data gathering is underway. A Flow/Rainfall Survey is complete. Further topographical survey work has been done. Early damage/benefits assessments are underway to ensure a cost beneficial scheme is achievable. An initial public engagement has been completed following short briefing sessions with Area Councillors. The on-site investigation work is largely completed. The options for the project are being considered. Interim technical reports have been developed for some option locations due to the complexity of the project. Initial discussions have now begun with a small number of landowners. Options are currently being refined. A Public Consultation Day to present the options on the scheme will take place mid December 2023.

The Monkstown environs flood risk mapping project is substantially completed, and final draft mapping and draft options have been submitted for review. It is planned to submit the flood maps to the OPW in December.

Uisce Éireann & The Effective Date

On September 20th, Dun Laoghaire Rathdown successfully implemented the 'Effective Date', which transferred the full responsibility for the delivery of Water Services in the County to Uisce Éireann. This means that for just over 50 Water Services' staff members, they are now under the management and control of Uisce Éireann, which includes their health and safety. This development is part of a National program. It will have no change to the current communication lines for Councillors, who, in relation to matters for Water Supply and Foul & Combined drainage, should use the dedicated phoneline and email facility, noted below. Similarly, Uisce Éireann will continue to arrange meetings between its staff members and the elected representatives of DLR.

Tourism Development

Dún Laoghaire Comedy Festival 2023

The second Dun Laoghaire Comedy Festival took place from November 9th -12th. This year's festival consisted of twenty shows and six venues over the 3-day event. The festival was hugely successful with almost 2,000 people attending. This is becoming one of the biggest comedy festivals in the country.

Christmas Festival Planning 2023

The Tourism Unit facilitated a number of stakeholder meetings with the aim to bring all the Christmas activities in Dún Laoghaire Town into one coordinated festival. These included Ice Skating, Santa Experience at the Maritime Museum, Christmas Lights, Carol Singing, Family Funfair and Santa's arrival to his grotto in the National Maritime Museum.

A coordinated social media launch to advertise the upcoming festival events and activities took place on November 20th with support from DunLaoghaireTown.ie, DLR Tourism and Dún Laoghaire-Rathdown County Council's Comms Office.

New Santa Arrival Event in Dun Laoghaire 25th November

For the first time in many years we organised a Santa Arrival Event in Dún Laoghaire Town. Working with the Town Team and The Dún Laoghaire Business Association we formed a project team to manage the event.

The event started at 12.00 noon at County Hall where Santa, accompanied by An Cathaoirleach, travelled by Festive Train to Myrtle Square. Other characters in the parade included an ice queen, giant teddy conductor, stilt walkers, a drumming band. Santa and An Cathaoirleach officially opened the first Dún Laoghaire Christmas Festival. Santa then continued the parade from Myrtle Square to the Peoples Park and finished in Haigh Terrace.

Christmas Baubles & Competitions

Our signature DLR Christmas Baubles have been installed around the county including Dún Laoghaire, Blackrock, Sandyford, Dundrum.

A number of social media Christmas competitions have started this month to highlight the things to do in the county this Christmas, including food and drink, horse racing, Santa experience, ice skating and cooking.



Dublin Region Tourism Officers Meeting

South Dublin County Council hosted the final meeting of 2023 for the Dublin Region Tourism officers Network. All four local authority tourism departments met to discuss current issues, updates on tourism strategies development and plans for coordinated work in the future.

Enterprise Hub by Quarterdeck in the Ferry Terminal

The members agreed to a S183 leasehold disposal of the terminal building to Quarterdeck at the Council meeting held on 13 June 2022 to operate an Enterprise Hub. Quarterdeck had indicated that they expected to incur expenditure of c€4m and began the process of seeking tenders for the necessary works after the lease became effective in July 2022. Widespread tender price inflation meant that the tenders obtained by Quarterdeck came in significantly higher than expected, resulting in a delay to the commencement of the works as Quarterdeck sought to get the project to a position where it was financially viable, based on the relatively short-term lease.

In the interim the following conditions of the lease have been satisfied:

- Insurance paid 30/09/22 which was confirmed to be in order
- Deposit of €200,000 lodged 13/12/22
- A photographic survey was provided on the 16/09/22 as required by the contract.
- 20-day notice re commencement of works was provided 23/12/22
- Stena Line Offices Fit out works substantially completed and further works underway on other parts of the building
- 1st quarter rent paid. 2nd quarter to be paid imminently
- Ground Floor Office Space Works underway
- Food Hall and Ground Floor Co-working space Works pending
- External Signage Design completed and submitted to planning control.
- Office Occupation There is still a strong level of interest from the business community due to the lack of space in the environs.
- Quarterdeck are currently progressing through building Control Compliances and hoping to have the fire cert in place Q1 2024.
- The Economic Development Team continue to engage with Quarterdeck on delivery of this project.

Cruise Ship Business

Dún Laoghaire Harbour

The 2023 Cruise season was very successful with positive feedback from Ships Agents, Cruise Ships officers and crew and most importantly the visiting cruise guests. Bookings for 2024 are strong with 95+ vessels currently booked into Dun Laoghaire Harbour. We are working with the Tourism Department, the Dun Laoghaire Business Association and the Dun Laoghaire Chamber of Commerce to maximise the local benefits of the cruise visitors.

Projects:

National Watersports Campus

DLRCC in partnership with Irish Sailing and the Irish Underwater Council have been approved in principle for Stream 1 Grant funding for the development of a National Watersports Campus. We have responded to requests for additional information and are now finalising the grant process and agreements with the project partners. An MOU has been signed with Irish Sailing and Diving Ireland in order to set out and agree the objectives of the project.

A concept brochure was presented to the Elected Members during the February Council meeting and has since been published. It is hoped that this initiative will assist in building momentum and support for the project. This document was presented to Councillors in February 2023.



A scheme to apply for additional "top-up" funding was announced in July and DLRCC have submitted an application for increased funding to assist with the impacts of inflation etc.

Berth 2 Fenders (Carlisle Pier)

A project to replace the Berth 2 fenders has been given approval to proceed to procurement stage. RPS Group have been appointed to carry out the design and procurement for this project. This project was tendered, and Sorensen Construction have been appointed to deliver the project. The project is now largely completed and this berth is back in use.

Berth 3 Fenders (Carlisle Pier)

Grant funding has recently been secured for a project to replace the Berth 3 fenders from the recent Brexit Local Authority Marine Infrastructure Scheme. This project was tendered, and Sorensen Construction have been appointed to deliver the project. The project is now on site and Berth 3 will remain closed to shipping for 2-3 months to facilitate the new fender installation. This project is likely to complete in January 2024

East Pier Revetment Repairs

Grant funding has recently been secured for a project to repair the sloping revetment at the back (east side) of the East Pier from the recent Brexit Local Authority Marine Infrastructure Scheme. This revertant provides the primary protection for the East Pier and has suffered some damage over recent years from the larger storms. Punch Consulting Engineers have been appointed to design and manage the project which is likely to be on site during the summer of 2023. Cunningham Civil & Marine have been appointed to carry out the works on this project. This project is now complete and was very successful. Delivering a marine engineering works project of this magnitude in the heigh of our busy season without any disruption is unprecedented. The work completed should help to protect the pier structure for many years to come.

Dublin Array Windfarm

The developers of the Dublin Array Windfarm have approached the Harbour about the possibility of establishing an Operations and Maintenance Base for the windfarm. It is hoped that there might be synergies with the Ferry Terminal project. Early engagement is ongoing with the developer's team to establish the exact requirements.

Skate Park

Due to delays with Irish Water in the original location, a temporary BMX was constructed in the car-park in Apna Park, behind the West Pier. The track is very popular with local young people. An adjacent Skateboard ramp is under construction at present.

Ice Rink

An Ice Rink will be installed in the Harbour for the months of November, December, and January. This will be one of the largest Ice Rinks in Ireland and tickets are now on sale.

Harbour Masterplan

A project to create a Masterplan to guide the future development of the Harbour has been approved. Tender documents are live for an Urban Design led multidisciplinary team to deliver this important project. The proposal includes significant public and stakeholder consultation, and will likely commence early in 2024.

Cleansing, Beaches & Coastal Protection Updates – November 2023

- Kavanaghs Corner (adjacent to the 40 Foot) Storm damage remedial repair project on bathing access points. A Contractor has started the remedial repair works and should be completed in early December.
- Coliemore Harbour granite wall remedial repair project A Contractor has commenced the onsite drilling and the rock anchor installation process. The works will be completed in early December, subject to weather conditions.
- Minor concrete repair works were completed to the platform at Seapoint Beach.
- Bathing water sampling is on-going at our 9 locations every week as scheduled since the 1st of June and will revert to sampling every fortnight after the 15th of September.
- Ringbuoy inspections and maintenance are on-going.
- DLR Baths DIr Cleansing crews are in place at the Baths and daily cleaning is underway to remove washed up seaweed, stones, sand etc.
- The Road Sweeping schedules were suspended in early October due to the start of the leaf fall season. Heavy leaf fall areas are being swept as per CRM worklists and site inspections. The Sweeping schedule will be reinstated in early February 2024.
- Gully Cleaning operations and early morning works are on-going. Gully Cleaning works that require Traffic Management are also on-going
- Public Realm cleaning is on-going presently with power washing and furniture cleaning.
- Junction Head sweeping and weeding has commenced and is being done on high priority areas throughout the county.
- The fleet of Smart Bins are being maintained and emptied on a daily basis throughout the county.
- Litter Picks and Blue Bag collections are on-going.

5. Public Lighting

Energy

Following a successful Audit on Monday 20 November, ISO50001 certification has been retained until the next surveillance audit in winter 2024. Since initial certification in 2016, each of the annual audits have been undertaken by Certification Europe, however this was the first year the audit was undertaken by National Standards Authority of Ireland (NSAI). There are only two approved ISO50001 certification bodies available to local authorities and the transfer to NSAI represents an opportunity to gain fresh insights from a new auditing body, as well as ensuring value for money. The transfer audit required site visits to each of dlr's Significant Energy Users (SEUs) as well as a comprehensive review of energy documentation. Thanks to the ongoing support of the Chief Executive, the Management Team, dlr Energy Team, and staff throughout the organisation, the auditors were impressed with dlr's energy performance and the "commitment to energy management and sustainability overall". Two opportunities for improvement were reported - to review fleet management effectiveness through improved data gathering and to update the Energy Manual for the benefit of those in energy champion and energy representative roles.

Zero Emissions Building (ZEB) Summit

On 21 November the Council & MosArt announced the launch of the ground-breaking Zero Emission Buildings (ZEB) Summit. This event scheduled to take place on 21 and 22 February 2024 will provide insights as we work together to build a world without carbon emissions. A workshop on the 21 February will take place in County Hall and will entail a detailed interactive study of our Shanganagh housing scheme.

Community Response Forum

The Ballyogan Regional Temporary Rest Centre opened its doors to Ukrainian nationals on 28th April 2022. The Centre has capacity to accommodate up to 392 displaced Ukrainian nationals for short periods. Over 10,527 people have stayed at the centre during this time. Among the facilities available in Ballyogan are separate laundry, sanitary facilities, internet access, television spaces, games room, chessboards, recreation room, libraries of Ukrainian books for children and adults, translation services, as well as online access to Ukrainian newspapers and magazines.

As part of the comprehensive wrap around service, accommodation services at the Centre are being supported by HSE staff providing onsite support to meet the healthcare needs of Ukrainian residents, and residents also have access to an offsite GP service 7 days a week.

The Community response to the crisis in Ukraine and the influx of Ukrainian nationals into the county is being led and coordinated by Dún Laoghaire-Rathdown County Council in collaboration with a wide range of stakeholders through the Community Response Forum, supported by a wide range of community and volunteer groups.

The Community Response Forum has been meeting since 28 March 2022 and has met twice in November 2023. Support services are being provided to those Ukrainian nationals who are being accommodated in the Ballyogan Regional Temporary Rest Centre and Larch Hill Scout Centre as well as in hotels and in private accommodation within the County.

A sub-committee of the Forum has also been established to provide support services to International Protection Applicants who are being accommodated in the County.

Local coordination efforts continue to provide comprehensive support services from Southside Partnership, HSE, An Garda Síochána, Department of Social Protection, dlr Education and Training Board, TUSLA, Community and Family Resource Centres, dlr Volunteers Centre and a number of other community and voluntary groups.

Community Recognition Fund

Community Department continued to work with the successful applicants under the Community Recognition Fund to progress their projects. This fund launched by Minister for Rural and Community Development Heather Humphreys and Minister of State Joe O'Brien on 24th January 2023 is designed to specifically support communities that have welcomed and are hosting families and citizens from Ukraine and other countries.

LCDC

There was one LCDC meeting in November and two new PPN nominees, one from the Community & Voluntary pillar, the other from the Social Inclusion Pillar of the PPN were in attendance.

Local Policing Fora (LPF)

A meeting of the Loughlinstown, Ballybrack, Shankill LPF took place on 7th November 2023. A meeting of the Dundrum Stillorgan LPF took place on 15th November 2023. A Public meeting of the Sandyford Stepaside LPF took place on 21st November 2023. The Joint Policing Committee meeting took place on the 14th of November 2023.

Age-Friendly & Social Inclusion Programme, November 2023 Report:

The <u>dlr Festival of Inclusion 2023</u> finished up during November with Diwali and India Fest celebrations. Dozens of community groups and organisations organised 50+ activities and 'Belonging | Muintearas' was the theme of this year's festival. Events ranged from 29 | P a g e



concerts, discussion panels, music, dance and theatre performances, information seminars, training events, classes, coffee mornings, tea dances, fashion shows, sports and physical activities, open days and official launches, workshops and much more.

dlr Festival of Inclusion 2024 will take place earlier in the year from the 16th – 26th May 2024. We hope that more community-based groups and organisations will take part in the festival to bring people together, engage and celebrate community well-being and raise awareness, provide supports and promote equality, diversity, integration and social inclusion across dlr.

India Fest

India Fest took place on Saturday 18th November in Leopardstown Racecourse and Indian culture, music, dance, food and the Diwali festival were celebrated with hundreds of performers and a large attendance. India Fest was organised by Social Space Ireland with support from DLRCC Social Inclusion Unit and Events office.

Chief Executive Frank Curran met with the **dlr Older People's Council** at their November meeting and a consultation presentation was made on the Dún Laoghaire Living Streets plans.

The **Cuairt & Cultúir Programme** is taking place currently across the county with artists and wellbeing facilitators running workshops and activities in 18 Residential Nursing Homes & Day Care Centres. The programme will run from November 2023 - March 2024 and is organised and funded by dlr Arts, Library Services and dlr Age-Friendly Programme.

The 'Sofa to Saddle' programme for over 55's was shortlisted for an Age-Friendly Transport Award at this year's **National Age Friendly Ireland Recognition & Achievement Awards** that took place in Wexford on the 30th November.

Comhairle na nÓg

Dir Comhairle na nÓg held their Annual Youth Conference on the 8th November in the Talbot Hotel. A total of 91 young people from both Secondary level schools and local Youth Groups attended the conference. The topic young people in attendance voted on as being of most important to them was School and School stress. This will form the basis of dir Comhairle's workplan for 2024.

Estate Management

The Estate Management Networking & Training Event took place on 25th November in Fitzpatricks Castle. This event provides an opportunity for each of the 12 Estate Management Forums to give feedback on their work and achievements in 2023 and share ideas for 2024.

Pride of Place

The 2023 Pride of Place Awards took place on 10th November. Pride of Place is an all-island competition which acknowledges the work that communities are doing all over the island of Ireland. The focus of the award is on people coming together to shape, change and improve daily lives in their communities.

DIr submitted nominations for four community groups with two groups receiving awards on the night. Hillview Estate received an award under the Housing Estates / Resident Associations category and dlr Community Support for Displaced Ukrainians received an award under the Communities Welcoming New Communities category.

Inclusive Community Engagement

Following on from the recent launch of 'A Guide for Inclusive Community Engagement in Local Planning and Decision Making', community staff participated in national training events targeted at Local Authority Staff. This training focused on skills and approaches for



facilitating activities to engage communities experiencing marginalisation in local planning and decision-making.

Arts

Dementia Inclusive Arts Programme

As part of the Creative Brainwaves Programme funded by Creative Ireland, dlr Arts Office hosted 2 events in November. On 7 November, a session for artists that work with people living with dementia with Professor Ian Robertson, building capacity for this area of arts practice. On the 21 November, a session for healthcare staff and artists was held in dlr LexIcon. Guest speakers from Reálta, the National Arts and Health organisation, artists, and an activity director with specialist experience in dementia gave presentations to the audience.

Exploring and Thinking Partnership: Early Childhood Arts

On the 16 November, the Exploring & Thinking Partnership of the four Dublin Local Authority Arts Offices hosted a special sharing day for artists, early childhood arts professionals and early years educators in Malahide Castle. This partnership supports early childhood arts in the Dublin region, over 25% of the national population of under 5-year-olds live in this area. The guest speaker was Dr. Suzanne Zeedyk, a developmental psychologist and research scientist from the UK. Four artists that have been funded through the partnership spoke about their work with early years children. Funded by the Arts Council and supported by the four Dublin Local Authorities.

Arts and Health Programme

Funded by the HSE, the dlr/HSE Arts and Health Programme supports a wide range of creative supports for older people, people living with dementia and people with disabilities in the County. In November the joint libraries, age friendly programme and dlr arts programme 'Cuairt agus Cultúr' began for 2023, supporting creative and wellbeing projects in residential and day service settings in the County, supporting 18 centres this year. 'Our Shed' funded by the HSE and Creative Ireland featured on RTÉs Nationwide on Friday 24 November, this project involved LBS Men's Shed working with poet Colm Keegan, supporting local men to creativity explore mental health through poetry and performance.

Municipal Art Gallery, dlr LexIcon

Dave Madigan's exhibition **'Landscapes and Oddities'** finished at the end of November. It featured large-scale paintings, wide vistas and aerial views of Dún Laoghaire-Rathdown and the wider Dublin area, as well as a large sculpture, inspired by the masts and riggings visible in Dún Laoghaire Harbour. The exhibition was the result of the dlr Visual Art Commission, funded by the Arts Council and supported by Dún Laoghaire-Rathdown County Council.

dlr First Frames Short Film Scheme

A Cast and Crew Showcase of two short films made by recent award winners of the dlr First Frames Scheme, Conveyance and Nay Day, was held in the Studio, dlr LexIcon on 16 November. The directors of the two films were interviewed on Arena, Radio 1, on 21 November. dlr First Frames is an initiative of Dún Laoghaire-Rathdown County Council's Arts Office and Economic Development Unit, managed and supported by IADT.

Baths Artists' Studios

Seoidín O'Sullivan completed her residency. She worked on a project called Sea Rise that creatively connected to the sea and involved numerous public-facing events. Several public events took place over November including a printmaking workshop; an Open Studio and making workshop; a seaweed pressing and printing workshop; and a session exploring the tides and sea levels of Dún Laoghaire. The artist brought in creative practitioners, a geographer and an oceanographer as part of the events.



Arts Grants

Applications for the dlr Arts Grants 2024 closed on the 25th October and 127 applications were received and were assessed throughout November by the Arts team and external experts.

Poetry and Music Beside the Sea

A series of poetry writing workshops culminated on the 8th November with a poetry and music performance in dlr Lexicon led by poet Jane Robinson and musician Malachy Robinson and attended by 70 people.

Sensory programming for the Neurodiverse

November's Studio Saturday was Festive Arts and Craft workshops, with artist Laura Steerman. Families had the opportunity to make clay candle holders, decorate Christmas stockings and other festive crafts to bring home. There were art stations and a paint spray wall. This family event took place in the Studio Theatre, dlr LexIcon on Sat 18 November and more than 230 attended. This was a drop-in event, with the hours of 11am-2pm specifically tailored for Neurodiverse families, and 2pm-4pm open to all.

Events for Adults

Social Prescribing Programme for Health & Well-Being

Funded by the Creative Ireland Programme, this collaboration between Southside Partnership and dlr Libraries aims to offer a targeted programme for people with disabilities, to help improve the mental health and well-being of participants and reduce the sense of isolation often felt by such vulnerable groups in our society.

A 4-week Creative Café began in dlr LexIcon in November. Four "taster" sessions were programmed, from watercolour painting, a local history talk on the Dublin mountains, the history of blues music and reading for well-being. Separately, a 6-week nature art course with artist Joyce Fitzpatrick took place. A further Creative Café will take place in February 2024, along with three additional 6-week courses.

Learn Watercolour with Svetlana Starikova (7, 14, 21 & 28 November, dlr LexIcon)

The course is intended for people who want to know or develop their skills in watercolour painting and is suitable for beginners. The classes aim to give students a sense of watercolour and a love for the medium.

Irish Language Classes (7, 14, 21 & 28 November, dlr LexIcon)

A 6-week class for beginners and intermediate Irish language learners, facilitated by Conradh na Gaeilge.

Literary events – Studio Theatre, dlr LexIcon

During November, we programmed the following high-profile author events:

• **Readers' Day** (Sat 25 November)

We welcomed over 130 visitors to dlr LexIcon for our third and final Readers' Day of 2023, this one programmed by writer Martina Devlin. The line-up on the day included a range of writers and thinkers, including Emily Hourican, Hazel Gaynor, Martin Doyle, Nuala Moore and Carlo Gébler. Professor Luke O'Neill was in conversation with broadcaster Anne Cassin.

• Séamus Heaney in his Own Words (Thurs 30 November)

Ten years on from his death, Seamus Heaney's legend continues to grow. Mick Heaney, journalist and son of the poet, shared insights into his father's life and work, along with his editor, friend and fellow poet Christopher Reid, who has edited the newly-published The Collected Letters of Seamus Heaney by Faber & Faber. The two were in conversation with writer Martina Devlin, and the evening included a dramatic reading of excerpts from the letters.

Guiding Lights: Music & Art from impressionism to jazz with Emile Conway (Mon 27 Nov)

This 4-week series started on 27 November and will run until 18 December in the Studio, dlr LexIcon. Vocal jazz artist Emilie Conway explores the relationship between music and art across different eras of the 20th century. Following the sound of the music and the smell of oil paint, the audience journey through time to la Belle Époque Europe, Paris, Munich, Vienna, east to St. Petersburg, through World War I, the Spanish flu, the Jazz Age, the Roaring '20s and the outbreak of World War II, fleeing to the safety, lights and glamour of New York in the 40s.
