Representational Payment for Councillors

and

Extension of Grace Period from 31 August 2014 to 1 April 2019 in Respect of the Payment of Gratuities to Certain Former Elected Members – Financial Emergency Measures in the Public Interest Act 2013

Dear Chief Executive

- 1. I am directed by the Minister for the Environment, Community and Local Government to refer to the Representational Payment (RP) for Councillors and previous circulars, the last of which was **LG 16/14** of 5 June 2014.
- 2. The annual rate of Representational Payment for Councillors with effect from **1 July 2013** remains unchanged.

- 3. However, following the signing of the <u>Public Service Pension Rights (No.2) Order 2015 (S.I.</u> <u>No. 547 of 2015)</u> by the Minister for Public Expenditure and Reform, in line with the provisions of the <u>Financial Emergency Measures in the Public Interest Act 2013</u>, where –
 - (a) a person was a member of a local authority on **1 July 2013**, and
 - (b) that person ceases to be a member of a local authority on or before **1** April 2019, and
 - (c) a gratuity, under the Local Authority Members (Gratuity) Regulations 2002 (as amended), becomes payable (Circular **S. 3/2007** refers),

the revised rates of payment from **1 July 2013** under paragraph 2 should be disregarded for the purpose of calculating the amount of gratuity payable in respect of that person; the rates (from 1 January 2010 to 30 June 2013) outlined in circular **LG 26/09** of 22 December 2009 should be used for this purpose.

- 4. For the avoidance of doubt the rates of payment from **1 July 2013** in respect of former Borough Councils and former Town Councils no longer apply, with effect from 1 June 2014, in respect of Representational Payments.
- 5. Where
 - any person ceases to be a member of a local authority from 2 April 2019 onwards, and
 - a gratuity, under the Local Authority Members (Gratuity) Regulations 2002 (as amended), becomes payable

the revised rates of payment from **1 July 2013** must be used for the purpose of calculating the amount of gratuity payable in respect of that person.
