# **Terms and Conditions**

- Applications are invited from housing estates, residential streets and towns or villages.
- All entrants must include a **map** which clearly indicates the area to be judged. Please highlight the roads and open spaces and the location of any special features.
- Entrants may include supporting documents to support their application and/or clarify particular challenges experienced in the previous 12 months (e.g. before and after photographs).
- Judging will take place in July and August 2024 as an unannounced visit from the competition judges.
- Judging will not take place during a scheduled local dlr event.
- The adjudicator's decision is final. No correspondence regarding the results will be entered in to.
- Closing date for receipt of applications is **5pm Friday 28<sup>th</sup> June 2024**.
- Results will be announced in October 2024.

15 marks will be awarded for presentation and maintenance of all properties, maintenance of frontages, boundary and gable end walls. Gardens, where applicable, should be presented to a good standard. Please give details of maintenance, weeding, pathcleaning and sweeping, etc. Please specify if it is the Council, a contractor or the residents who are involved in each activity.

5 marks will be awarded for community actions that have been carried out to improve physical streetscape, paving, lighting, signage, or local accessibility for all.

# **Natural Habitats and Biodiversity**

# (10 marks)

Please outline how you improve the natural environment through planting and maintenance. Do you remove the use of pesticides and herbicides?

# **Litter Management**

10 marks are awarded for appearance during adjudication and 10 marks are available for awareness, actions and litter control strategies.

Adjudication will focus on the absence of litter, fly-posting and dumping, evidence of litter control strategy, litter patrols, community clean-ups and the promotion of anti-litter awareness throughout the community.

# Graffiti Management

10 marks are available for policies and procedures to manage graffiti. 5 marks are available for appearance during adjudication. Marks will be awarded for absence of graffiti and evidence of graffiti control strategy, including regular patrols and promotion of anti-graffiti awareness throughout the community.

# **Community Engagement**

10 marks are available for community involvement in environmental actions listed below. Please indicate the level of voluntary commitment (general involvement of the community at clean-ups, planting days, engaging new residents, meetings, etc.).

Do you involve all ages e.g. schools, Men's and Women's Sheds, Brownies or Scout groups etc.?

# **Climate Action and Sustainability**

5 marks are available for sustainability actions that reduce your group's environmental impact. Do you promote sustainable practices such as recycling, composting, water conservation or reducing single-use plastics and waste? Have you completed an up-cycle project or reused salvage materials for landscaping or biodiversity projects (e.g. a planter made from up-cycled wood, a sign made from up-cycled materials)?

5 marks are also available for climate actions that raise awareness of climate change and what communities can do in response, such as encouraging local food production and consumption, use of local resources, reducing food waste and tree planting initiatives. Raising awareness of sustainability and climate action through workshops, courses and campaigns is also welcomed.
