# Information submitted by the Director of Services

➢ Richard Fitzpatrick, gave a presentation on the Climate Action Plan 2024 − 2029.

The Plan was on public consultation from 20<sup>th</sup> September until Friday 3<sup>rd</sup> November 2023. Following public consultation a Chief Executive report on submissions is being prepared and will issue to Elected members in early January 2024.

All Local Authorities are required to make and approve their Climate Action Plan by 23<sup>rd</sup> February 2024.

Following Questions from Committee members the presentation was Noted.

Martina Kehoe gave a presentation on the draft Litter Management Plan 2024 – 2026. It was presented to both area Committees in September 2023 and was presented to the Environment and Climate Action SPC in September 2023. The Plan was on online Consultation in October 2023 and shared with all staff and Councillors in October 2023.

Following the Consultation period sixteen submissions were received. A number of revisions were made following the Consultation period.

The draft Litter Management Plan is going to next Council meeting for approval. Martina responded to questions from the Committee members.

Following Questions from Committee members the presentation was **Noted.** 

> The Update on the Draft National Waste Management Plan for a Circular Economy was presented by Martina Kehoe.

The Plan was on public consultation from 3<sup>rd</sup> May until the 5<sup>th</sup> July 2023 and 381 submissions were received. Martina spoke on the submissions, and the high level targets and revisions.

The Plan is to be made collectively by all Chief Executives on agreed date. Launch date early March.

Following a question from Cllr. Smyth regarding the providing a Rediscovery Centre in the County Martina Kehoe responded that she and Paul Kennedy have spoken to the Rediscovery Centre about locating a Centre in Dun Laoghaire.

Cllr. Jim O'Leary enquired about the School Book Initiative and Martina replied that she had talked to the County Librarian regarding the Bring a book, Take a book initiative.

The presentation was **Noted.**
