PROPOSED ROAD CLOSURES

Section 75 of the Roads Act, 1993 –
Temporary Closing of Roads - Notice of Intention –
Temporary Closure of M50 Junctions 14 to17 Southbound

Dún Laoghaire-Rathdown County Council, on behalf of Transport Infrastructure Ireland, gives notice in accordance with Section 75 of the Roads Act, 1993 that it intends to close:

- The M50 **Southbound** between Junction 14 (Dún Laoghaire) and Junction 17 (M11 merge).
- The M50Junction 15 **southbound** merge slip road
- The M50Junction 16 **southbound** merge slip road

Dates of the closure: 25th September, 2019 - 11th October, 2019.

Hours of closure: Monday - Sunday 10pm - 6am

The purpose of the closure is to facilitate the resurfacing of the pavement.

On any given night, only one carriageway direction on the M50 shall be permitted to be closed and diverted.

A Traffic Management Plan will be in place and diversion routes clearly signposted, as agreed with Dun Laoghaire Rathdown County Council and An Garda Síochána. Local and emergency access will be allowed at all times.

Diversion of M50 mainline traffic will be via the N31 Leopardstown Road, R113 Leopardstown Road, N11 Dual Carriageway and M11.

Diversion of traffic wishing to travel on the M50 southbound from Junction 15 will be via Murphystown Way and Ballyogan Road to M50 Junction 14. Traffic will proceed along the N31 thereafter as above.

Diversion of traffic wishing to travel on the M50 southbound from Junction 16 will be via R118 Wyattville Road, N11 Dual Carriageway, and M11.

ROAD WORKS SPEED LIMIT ORDER

Road Works Speed Limit Order, No. 1 of 2019 on the M50 Motorway in the County of Dún Laoghaire-Rathdown

Notice is hereby given that Dún Laoghaire-Rathdown County Council, in exercise of the powers under Section 10 of the Road Traffic Act, 2004, in the interests of road safety and to facilitate the resurfacing of the M50 Motorway, has made an Order entitled:

Road Works Speed Limit Order, No.1 of 2019 on the M50 Motorway in the County of Dún Laoghaire-Rathdown to apply a road works speed limit as follows:

M50 Southbound:

will run from 09/09/2019 until 11/10/2019 or for the duration of the works whichever is the earlier.

Description of speed limit order 80km/hr:

- Part of the Southbound M50 between a point 120 metres South of the existing R117 overbridge to a point 620 metres South of the R117 overbridge (Total 500m in length).
- Part of the Southbound M50 diverge at Junction 14 from the start of the diverge taper to a point on the diverge ramp 420 metres West of the yield line of the diverge off-ramp at Junction 14 (Total 485m in length).

Description of speed limit order 60km/hr:

- Part of the Southbound M50 between a point 620 metres South of the existing R117 overbridge to a point 120 metres South of the M11 overbridge (M50 Junction 17/M11 J4) (Total 8,000m in length).
- Part of the Southbound M50 merge at Junction 13 from a point 50 metres East of the start of the merge on-ramp at M50 Junction 13 to the end of the merge taper (Total 1250m in length).
- Part of the Southbound M50 diverge at Junction 15 from the start of the diverge taper to a point on the diverge ramp 40 metres West of the stop line of the diverge off-ramp at Junction 15 (Total 555m in length).
- Part of the Southbound M50 merge at Junction 15 from a point 75 metres South
 of the start of the merge on-ramp at M50 Junction 15 to the end of the merge
 taper
 (Total 480m in length).
- Part of the Southbound M50 diverge at Junction 16 from the start of the diverge taper to a point on the diverge ramp 60 metres West of the stop line of the diverge off-ramp at Junction 16 (Total 525m in length).

Part of the Southbound M50 merge at Junction 16 from a point 65 metres South
of the start of the merge on-ramp at M50 Junction 16 to the end of the merge
taper
(Total 575m in length).

M50 Northbound:

will run from 23/09/2019 until 08/11/2019 or for the duration of the works whichever is the earlier.

Description of speed limit order 80km/hr:

 Part of the Northbound M50 between a point 335 metres South of the existing Crinken Lane over bridge to a point 165 metres North of the Crinken Lane overbridge (Total 500m in length).

Description of speed limit order 60km/hr:

- Part of the Northbound M50 between a point 165 metres North of the existing Crinken Lane overbridge to a point 300 metres West of the R113 overbridge (Total 8000m in length).
- Part of the Northbound M50 diverge at Junction 17 (M11 Junction 4) from the start of the diverge taper to a point on the diverge ramp 70 metres North of the Lordello Road overbridge (Total 450m in length).
- Part of the Northbound M50 diverge at Junction 16 from the start of the diverge taper to a point on the diverge ramp 55 metres East of the stop line of the diverge off-ramp at Junction 16 (Total 605m in length).
- Part of the Northbound M50 merge at Junction 16 from a point 80 metres West of the start of the merge on-ramp at M50 Junction 16 to the end of the merge taper (Total 700m in length).
- Part of the Northbound M50 diverge at Junction 15 from the start of the diverge taper to a point on the diverge ramp 130 metres East of the stop line of the diverge off-ramp at Junction 15 (Total 500m in length).

Diversion of M50 mainline traffic will be via the N31 Leopardstown Road, R113 Leopardstown Road, N11 Dual Carriageway and M11.

Diversion of traffic wishing to travel on the M50 southbound from Junction 16 will be via R118 Wyattville Road, N11 Dual Carriageway, and M11.

Section 75 of the Roads Act, 1993 Temporary Closure of Tivoli Road and Corrig Road ***

Dún Laoghaire-Rathdown County Council has made an order to temporarily close **Tivoli Road and Corrig Road**, from the junction of Tivoli Road with York Road to the Junction of Corrig Road with Glenageary Road Lower from **6**th **August, 2019** to **20**th **September, 2019**.

A Traffic Management Plan will be in operation and local access will be maintained at all times and diversion routes will be clearly signposted.

The purpose of the closure is to facilitate road restoration and associated works.

<u>Phase 1</u>: Road/Footpath Restoration and associated works will start during week commencing: **Monday, 12th August 2019** for duration of **6-Weeks**. Works will be undertaken between 08:00 and 18:00 hrs. (Monday to Saturday).

A Traffic Management Plan and signed detours will be in operation and local access will be maintained.

Traffic Management arrangements will remain in place over night for the duration of the works.

» Frascati Road (Southbound) and George's Avenue Junction, Blackrock *** (Night Works)

Cabling works on behalf of ESB will commence on Tuesday, 17th September 2019 between 19:00 and 23:00 hrs.

A Traffic Management Plan will be in operation.

» George's Avenue on Rock Road Side (part of) **

A Stop / Go Traffic Management Plan will be in operation.

» Goatstown Road, Goatstown **

Manhole inspection works outside / between Our Lady's Grove Schools and Roebuck Downs Entrance Junction on Goatstown Road will commence on Monday, 16th September 2019 for one day between 10:00 and 13:00 hrs.

A Traffic Management Plan will be in operation.

» Clonkeen Road Junction of Bray Road ***

Civil works will commence on Monday, 16th September 2019 until Friday, 20th September 2019 between 10:00 and 16:00 hrs.

A 3-Way Traffic Management Plan will be in operation.

» Glenamuck Road (outside Rockville Development) **

Watermain works will commence on Tuesday, 17th September 2019 until Thursday, 19th September 2019 between 10:00 and 16:00 hrs.

A Stop / Go Traffic Management Plan will be in operation.

» Stepaside Lane, at Garda Station, Stepaside ***

Works on behalf of Gas Networks Ireland will commence on Thursday, 19th September 2019 for one day between 10:00 and 16:00 hrs.

A Stop / Go Traffic Management Plan will be in operation.

» Public Lighting Lantern and Bracket Upgrade Works **

Public lighting lantern and bracket upgrade works will commence on: Monday, 16th September 2019 on:

Nutgrove Avenue Improvement Works ***

Road Maintenance Section is carrying out road restoration / road surfacing works on Nutgrove Avenue in the coming months from the junction with Nutgrove Way to the Church of the Good Shepherd adjacent to Oakdown Road. In advance of this, minor works will be carried out along part of the route to improve cycling facilities at the junctions and along the route.

The outline programme of works is as follows:

- Cycle track improvement works from 9th September 2019 for 3-4 weeks.
 Hours of work 10:00 to 16:00 hrs.
- Ground works/ Road Restoration works October to November Mainly night works.

A Traffic Management Plan will be in operation for the duration of the works

Traffic lane restrictions or footway/cycle track restrictions may apply for each phase of the works.

Haigh Terrace and Lower George's Street, Dún Laoghaire ***

Clonmel Enterprise Ltd. have been appointed by Dún Laoghaire-Rathdown County Council to undertake the Dún Laoghaire Upgrade Scheme along Haigh Terrace, Metals Walkway and Lower George's Street.

The works will commence on 2nd September 2019 and run for 16 consecutive weeks. When complete the project will create a significantly better environment and better pedestrian connection between the seafront and the town.

The works at Haigh Terrace commenced on 2nd September and undertaken on a phased basis with working hours restricted between 08:00 and 18:00hrs.

Clonmel Enterprises Ltd. will implement various Traffic Management Plans along Haigh Terrace with access along Haigh Terrace and the Maritime Museum maintained.

The on-street parking spaces along Haigh Terrace will be suspended for the duration of the works.

Old Connaught Avenue/Dublin Road, Bray **

Works are being carried out on the Old Connaught Avenue / Dublin Road in Bray by GMC on behalf of Irish Water from Tuesday, 6th August until Friday, 20th September 2019.

There will be no access to Old Connaught Avenue from the Dublin Road.

A diversion is in place via Dargle Road, Fassaroe and Junction 5 North.

Sandyford Road - at the entrance to the Council Depot **

Re-alignment of the cycle track at the entrance to the Council Depot commenced on Monday, 9th September 2019 until Friday, 20th September 2019.

A Traffic Management Plan will be in operation between 10:00 and 16:00 hrs. on weekdays.

Brighton Road, Foxrock **

Service Connection works for Four Ferns Nursing Home Development on Brighton Road, Foxrock commenced on Monday, 2^{nd} September 2019 until Friday, 20^{th} September 2019 between the hours of 10:00 and 16:00 daily.

A Stop / Go Traffic Management System and Lane restrictions will be in place for the duration of the works.

Marshalls will work to facilitate the safe movement of all road users.

Kilmacud House / Kilmacud Road Upper ***

John Sisk & Son (Holding) Ltd. commenced the drainage works along Kilmacud Road Upper to service a new development at Kilmacud House on Monday, 2nd September 2019 until Friday, 20th September 2019 between 10:00 and 16:00 hrs.

A Traffic Management Plan will be in operation.

N11 Cabinteely (Closure of bus lane – Northbound and Southbound carriageways) ***

Works commenced on Tuesday, 26th February 2019 to construct a new signalized junction and construction of 135 m of new Druid's Glen Road until December 2019.

A Traffic Management Plan will be in operation.

Rosemeen Garden / Granite Hall, Dún Laoghaire *

Footpath restoration works commenced on Monday, 26^{th} August 2019 until Friday, 20^{th} September 2019 between 08:00 and 18:00 hrs.

A Traffic Management Plan will be in operation and local access will be maintained at all times.

N11 and N31 National Road Re-Signing Contract **

Work has commenced on the upgrade of traffic directional signage at various junctions along the N11 and N31. The project involves the removal and disposal of existing signage, construction/installation of new sign faces, sign face panels and patches, and new posts/supports and foundations at a number of locations.

A Traffic Management Plan will be in operation for works on the N11 and N31. Traffic lane restrictions or footway/cycle track restrictions may apply for each phase of the works.

Clonskeagh Road, Clonskeagh *** from Leinster Lawn to Whitethorn Road

Upgrade of pedestrian and cycling facilities along Clonskeagh Road commenced on Monday, 4th March 2019.

Permanent Traffic Management will be in place *until late September 2019* with traffic restrictions between 10:00 and 16:00 hrs. on weekdays.

Brennanstown Road, Foxrock - new Residential Development ***

New footpath, traffic roundabout, road resurfacing and the installation of utility services commenced on Monday, 15th July 2019 until Friday, 15th November 2019 between 10:00 and 16:00 hrs.

A Stop / Go Traffic Management Plan will be in operation.

N11 Cabinteely (Closure of North and Southbound bus lanes) ***

Closure of north and southbound bus lanes and restrictions on cycle lanes will continue in order to facilitate road widening works near both Circle K filling stations on N11, Cabinteely. This phase of the works is scheduled for completion *September 2019*.

A Traffic Management Plan will be in operation.

Windsor Terrace - Dún Laoghaire Baths Redevelopment **

Construction commenced on the redevelopment of the Baths site on Monday, 23rd April 2018. Construction is programmed to be completed by Q1 2020.

During **September**, internal construction of the building will continue with the upper level services / floors / walls being installed. Construction of the new sea walls and various other walls on the site will continue. There should be no Traffic Management restrictions on Windsor Terrace with the exception of the delivery of materials, which will be short term and between 10:00 and 16:00 hrs. Monday – Friday.
