

Background

Following legislative changes in 2014 related to the local government strategy 'Putting People First', the remit of local authorities includes a renewed and clearer role in economic and community development. In this regard, each Local Authority is required to develop and make a Local Economic and Community Plan which is a statutory plan for the area.

Dún Laoghaire –Rathdown's Local Economic and Community Plan 2016 – 2021 was developed throughout 2015 and adopted by the County Council on the 14th December 2015.

The LECP is structured around 8 high level goals, 21 thematic objectives and 156 individual actions which are aimed at supporting community development, enhancing quality of life and driving economic development for the County.

Monitoring of the progress and implementation of the Community Objectives and relevant shared Community and Economic Development Objectives is undertaken by the Local Community and Development Committee during the year with reports, presentations and updates to the LCDC which includes this Annual Report.

This Report tracks overall progress during 2018 with implementation of the LECP Objectives that come under the remit of the LCDC for oversight. It also highlights issues which may require further consideration or may need review.

The Economic Development and Enterprise Strategic Policy Committee monitor progress and implementation of the economic development and enterprise objectives and related shared economic and community objectives for which the SPC is responsible for.

Progress on the LECP is dependent on the County Council and Lead Partners supporting implementation of key objectives for which the LCDC has oversight. These include shared Community Objectives numbers 7 to 14 as well as Community Objectives numbers 15 to 21 inclusive. These are the community and shared community and economic development objectives.

Partners who have directly supported implementation and in many cases, delivery of key objectives during the past 3 years include; all departments of Dún Laoghaire Rathdown County Council, Southside Partnership DLR, An Garda Síochána, County Childcare Committee, Health Service Executive, Crosscare, Children's and Young



People's Services Committee, Tusla, Comhairle Na nÓg, DLR Volunteer Centre, Drugs and Alcohol Task Force, DSP, PPN, IADT and DDETB. The on-going support and engagement of partners is much appreciated and is vital in helping the LCDC in achieving the LECP goals and objectives which were developed and agreed by the LCDC in 2015.

There have now been 3 full years of implementation since the adoption of the Strategy and good progress is being made overall. It is timely now for the LCDC to review overall progress for 2018 and to consider areas for potential focus or greater collaboration going forward. The LCDC held two Workshops in 2018 in order to assess key priorities for 2018. The workshops explored issues highlighted in the LECP 2017 Annual Report for planned 2018 community and shared community actions and looked at identifying areas of collaboration between agencies where the LCDC can be most effective. The workshops held on 14th March and 3rd May were considered to be a worthwhile exercise in establishing areas for particular focus in 2018 and the benefits of interagency collaboration for achieving progress.

The following report clarifies key achievements made on implementation during 2018 and highlights some of the key issues to be considered by LCDC.

Actions are wide and varied in terms of scope, definition, responsibility and level of stakeholder engagement. An owner, lead departments, support departments, and timelines have been assigned to each action. Action owners were requested to provide updated information on their actions for 2018.

The current status of each action has been assessed and highlighted using a traffic-light system. This system assists with reporting and monitoring progress and in identifying actions that require attention or review.





An online reporting system 'Viclarity' was developed to aid monitoring and tracking progress and reporting of LECP. This requires each action owner to update their actions once and enables reports to be generated regarding specific objectives or overall analyses. This aids with collection of data, analysis, reporting and implementation



Overview of DLR LECP actions by Objective

The pie charts below gives the breakdown of progress being made on both Community and shared Community actions (shared Economic and Community Actions) under 15 of the LECP objectives. The Plan is in place to 2021, and to date some 58% of Actions have been completed, with a mix of on-going activities and other areas where more work is needed or in some cases, there may be Actions that require further consideration or review, and these will be raised under each of the relevant objectives in the following sections of the report.









Community Objectives

2018 Achievements for Objective 15 include;

- HSE with other public and private partners continued working in collaboration with DLR LCDC and DLR CYPSC to implement actions for Healthy Dun Laoghaire-Rathdown.
- Round 1 Healthy Ireland Actions completed and report presented to LCDC on 19th September http://www.healthyireland.ie/
- Round 1 Healthy Ireland Actions had a direct impact on 1,970 individuals across a range of target groups in the county.
- Joint application for round 2 Strand 1 submitted by DLR LCDC/CYPSC for maximum funding of €112,100. The application contained 12 separate actions impacting on the health of a broad range of citizens in the Dún Laoghaire-Rathdown area.
- Inter-agency development of a Dún Laoghaire-Rathdown Healthy Ireland Strategy continued as part of the Healthy Ireland Programme.
- DLR Libraries supported wellbeing through a diverse cultural and community development programme across the 8 branches. This has included Library



Voices, Mountains to Sea, LexIcon Lab Programme, engaged NALA initiative for literature, Summer Stars Reading, People on the Pier, Family Days, STEM Bootcamp for 8 secondary schools and Mind reading Mental Health Conference as well as the annual Bealtaine Festival

- County Sports Participation Strategy 2018-2022 research, consultation and development of new 5 year strategic plan completed and launched
- The Sports Partnership delivered a range of training courses, workshops and targeted physical activity programmes for all ages, levels of ability. Some examples included:
 - o dlr Community 5K, which attracted 1,000 people of all ages and abilities
 - The Daily Mile, at which 700 children from 9 schools participated in as part of Active Schools Week
 - Active Dance programme rolled out in four additional schools
 - Woodlands for Health 12 week project targeting participants with poor mental health using weekly guided walks to manage symptoms rolled out a second programme
 - Junior Parkrun established two new runs in Deerpark (average of 50 children) & Marlay Park (average of 180 children).
 - Operation transformation walk with 180 participants
 - Daily mile on-going in 25 primary schools
 - Disability Sports Inclusion new multi-sport activity club for children with a physical disability in Loughlinstown, Inclusive Cycling programme for children with additional needs, Inclusive GAA programme being progressed in local clubs, Disability Sport Open Evening for children with a disability and their families, dance based activities for adults with disabilities
 - Athletics for primary schools event with 320 participants



Community Objective 16: Support Families within the County

2018 Achievements for Objective 16 include;

- DLR CYPSC has continued to make good progress with interagency work to develop a Plan for Children and Young People in dlr.
- Focus groups have been established including health and mental health, and Safety, and opportunities and priorities are being identified. Needs analysis and countywide demographic analysis completed which will help to inform a CYPSC 3-year plan currently under development.
- Consultation by DLRCC was held with children and young people during November to hear their views on dlr Council services. A total of 137 children and young people from dlr participated in the workshop or completed the survey, with ages ranging from 5 to 18 years old.
- Southside Partnership continued to support and make progress including;
 - DLR Youth at Risk Network offering information, support and training and a space to reflect on practice and plan collaboratively for frontline staff.
 - Continue to convene the 0 3 Interagency/Community Parenting
 Support Initiative. Funding application submitted to Tusla QCBI innovation fund to sustain and grow the work with 0 3 in the county
 - Continue to provide Domestic Violence supports, with SAVE, to targeted women in DRL through FREDDA and SAVE Counselling Service.
 - Through the Southside Community Training Network continue to work with Stakeholders in providing training, information and supports to targeted communities
 - Continue to host the DLR HFME, DLR DATF, DLR PPN, LWwD, DLR Healthy Ireland and SAVE Forum,



- Ongoing supports for people with dementia to remain active in the local community through the hosting and support of the LWwD Volunteer Project. 7 community based activities in 5 locations each week.
- In partnership with DLR Healthy Ireland (hosting of project and line management of development worker) successfully completed a series of actions targeting young people, adults and seniors in DLR.
 Southside Partnership also continued to link with schools and relevant agencies to support after-schools and out of school clubs in Mounttown and Loughlinstown, to support families within the County
- Exit 15 Programme Exit 15 is delivering within the Ballyogan and surrounding area and is significantly increasing community input





2018 Achievements for Objective 18 include;

- The Joint Policing Committee and Local Policing Fora provide a forum for identifying and discussing appropriate responses to issues relating to public safety and policing. A 6 year JPC action plan has been developed and is being implemented http://www.dlrcoco.ie/en/community/joint-policing-committee-local-policing-forums
- The JPC Strategic Plan 2016-2021 contains 18 individual actions across three strategic Goals:
 - 1. Supporting and promoting Crime Prevention in DLR
 - 2. Enhancing Community Safety & Security in DLR
 - 3. Facilitating Community Engagement and Collaboration on Safety Issues
- An annual Implementation plan for 2018 was developed with progress achieved against objectives related to the 3 goals. There was ongoing



engagement with Policing Authority regarding Policing Priorities and input to a workshop.

- JPC annual public meeting was held in November and highlighted key safety and crime statistics for the County and addressed any issues of concern or query.
- There was attendance and input to a refresher workshop in February by Local Policing Forum Committee members regarding the recommendations arising from the Review of Local Policing Forums.
- A meeting of LPF chairs was held in October, at which agreements were made on all key recommendations, including: Working group has been established, Key Principles Document under development, Annual Work Plans prepared
- Three Local Policing forums are in place and meet regularly for
 - (1) Loughlinstown / Shankill / Ballybrack,
 - (2) Sandyford / Stepaside and
 - (3) Central Dún Laoghaire.
 - These LPF meet every two months. Local programmes are developed for each LPF based on the JPC Annual Plan. Progress reports were presented at JPC meetings
- Operation Crossover is in place to ensure maximum high visibility beats and patrols by An Garda Síochána across the County. All personnel (uniform, plain clothes etc.) are made available for the Operation
- Operation Tombola is implemented throughout the DMR East during the Halloween festivities. High visibility patrols are deployed to diminish antisocial behaviour and ensure an enjoyable and safe holiday can be observed throughout the Community
- Operation Irene operated very effectively with very positive feedback received through the Central Dún Laoghaire Local Policing Forum http://www.dlrcoco.ie/en/news/general-news-public-notices/launch-operation-irene-2018
- There are now 157 Neighbourhood Watch schemes (an increase of 16) being supported by the AGS and Dún Laoghaire Rathdown County Council, together with 14 Business Watch schemes
- Safety and Security Workshops for Older People delivered at two events in Ballinteer (April) and Loughlinstown (June) with presentations on;
 - Crime Prevention Focusing on Home Security
 - Safety and protection of the Older Person Falls Prevention https://www.garda.ie/en/Crime-Prevention/-Streetwise-.pdf
- Three Youth Diversion Projects currently exist in dlr
 - Castle Project Ballyogan

- An analysis of Domestic Violence incidents, for the years 2016—2018 has been conducted by An Garda Síochána. The Inter-Agency 'Safe Homes' Project continues to be run by Sonas in conjunction with An Garda Síochána, providing support for victims of Domestic Violence
- A number of text alert projects are in place in some parts of the county. Dún Laoghaire Garda Superintendent is exploring further avenues for development.



 Associations, Clubs and other organisations in the development and use of their public open spaces within Estates and in the Public Parks
- Capacity Building Training Programme developed rolled and out to management committees of all Community Facilities and community groups by the Council
- The Community Development Team held 8 information sessions in September providing advice and guidance to help groups to maximise their chances of securing funding with the Councils new online grant system.
- During 2018 the Volunteer Centre saw the further development of the DLR



2018 Achievements for Objective 20 include;

2018 Achievements for Objective 21 include;

- 494 groups were registered with the PPN at the end of 2018, an increase of 94 groups compared to 2017 http://dlrppn.ie/ this includes 392 Community & Voluntary, 88 Social Inclusion and 14 Environmental groups
- The PPN Steering Committee met on a monthly basis to plan and organise the 2018 programme of work.



- Two (2) plenary meetings of members were held in 2018 on April 25th and November 7th 2018
- 23 nominees represented the PPN on six Strategic Policy Committees
 The PPN was also represented on the Local Community Development
 Committee, Joint Policing Committee, Rural Taskforce, and the Smart Dublin
 Advisory Group
- DLR PPN and Dublin South FM piloted two radio programmes based on PPN monthly ezine. The programme, 'Community Connections' was aired in December and will be available as a podcast on dublinsouthfm.ie and dlrppn.ie
- The PPN delivered 8 training sessions for members in October, November and December 2018

 - This site will rationalise the operations of each community facility leading to a consistency in terms of quality and presentation of relevant community information and lend itself to be an information sharing tool as well as a support system for our community
- DLRCC supported the URBACT III network called CHANGE project. The URBACT
 City festival took place in Lisbon, Portugal on September 13th & 14th 2018.
 CHANGE Project finished in September 2018 All project commitments
 completed.
- dlr Comhairle na nÓg continued to progress their work plan under the theme
 of Youth Mental Health. dlr Comhairle na nÓg produced a booklet called
 'Comhairle Tips for Positive Mental Health for Young People' which was
 distributed to all young people in attendance at 2018 AGM, this booklet will
 be distributed to all secondary schools and was showcased at the National
 Showcase held in Croke Park in November 2018



- 239 units delivered through Construction, Part V, CAS, leasing and acquisition Strategy for period Jan to Dec 2018.
- 405 units were provided under RAS, HAP and Homeless HAP under re-building Ireland Delivered 72 allocations to homeless households
- 19 persons downsized during 2018
- Choice Based Letting (CBL) was rolled out fully in 2018 to contribute to a
 decrease in refusals and contribute to a faster allocation of vacant properties -76
 Choice Based Lettings (CBL) offered in 2018
- 1,541 total inspections carried out in 2018. The Joint Regional Tender with Fingal County Council for the Provision of Rental Property Inspections 2019-2023 has been completed



- A new Supported Temporary Accommodation (STA) was delivered in Q4 2018 with 10 beds for homeless single
- Cherrywood Town Centre planning application which includes provision for a new library/exhibition space of c1,500sqm received its grant of permission in May 2018. Works commenced on site at the end of Q4 2018

Overview of Progress with Objective 7:

The majority of actions under this objective relates to access to housing and related services. There has been a significant focus of activity and resources, particularly by Dún Laoghaire-Rathdown County Council, to help ensure that targets for social housing in 2018 have been achieved, and that good progress is made on developing a pipeline for the future to support with increasing availability of social and affordable housing across the country. Good progress has been achieved and the actions here are significant and on-going to maintain progress. *The following action was identified at the Workshops to be given particular focus in 2018*



Shared Objective 8: Support life-long learning, enterprise development and strengthen employment in local communities

13 Actions, of which 8 are for LCDC oversight



2018 Achievement for Objective 8 includes;

- The DIr Social Inclusion Community Activation Programme (SICAP) implemented by Southside Partnership provided assistance to support community and enterprise development and supports with access to employment and learning for individuals during 2018 – achievements include;
 - o 712 were assisted on a one-to-one basis
 - 45 Community Groups received advice and support
 - o 564 children received advice and development support
 - o 714 individuals received employment support
 - o 122 individuals were supported into self-employment
 - 212 training places were filled on enterprise/small business related workshops
 - 42 young people not in education, training or employment received one to one supports
- A 6-week 'Introduction to Social Enterprise' training course was facilitated
- The DLR Student Enterprise Awards were held on 23rd March 2017 with 33
 School Teams representing 15 schools in attendance
- 'Exploring Social Enterprise' event took place on 11th October in Blackrock Education Centre. The event formed part of the DLR Festival of Inclusion 2018. The aim was to raise awareness and understanding of social enterprise while providing networking opportunities for social enterprises, community groups, and local and national support services.
- In partnership with DDL ETB the successful completion of two Major Awards for 11 local women and the ongoing support for an additional 19 women to



complete their Major Award in Care of the Older Person and/or Community Childcare in the Ballybrack area

- On-going engagement and collaborative work with the DDL ETB on the planning and delivery of accredited QQI modules in Ballybrack. 80 course participants were facilitated to complete five QQI L5 minor modules. 11 participants graduated with a Major Award
- New European Funded Integration Project, WEMIN funded by the AMIF funds underway. WEMIN focuses on the social, educational and professional aspects of inclusion for targeted women, migrant and Irish, in DLR and in the other EU countries involved
- Engagement with European partners through the AMIF fund to support the integration of migrant women. Completion of a Level 5 Major Award for local women in the RAPID area
- 18+ individuals, interested in developing social enterprises, have received oneto-one supports and/or attended social enterprise related training workshops

Overview of Progress with Objective 8:

Good Progress has been made through the SICAP Programme with most headline targets achieved for 2018, through Southside Partnership providing assistance to support community and enterprise development and access to employment and learning in partnership with DDLETB during 2018.

Actions are on-going and progressing well within this objective, however there are areas for consideration/focus for 2018. The following actions were identified at the Workshops for particular focus:

Action for Consideration/ Progression for 2019

Action 8.4 – Build an environment that makes it easier for people to start enterprises to address social issues and build a network for collaboration

Action 8.6 – Collaborate with Higher and Further Education and Training Providers in dlr to promote education access programmes for disadvantaged communities including unemployed residents




Shared Objective 9: Support locally-based creative and knowledge enterprises, and strengthen up-skilling within the County, including support for start-ups and for business incubation facilities

2018 Achievement for Objective 9 includes;

- DLR LCDC Promoted the Social Enterprise Development Fund with all its stakeholders and on dlr social media platforms. The fund is a €1.6 million fund which will be delivered over two years; 2018 2020. The fund was created by Social Innovation Fund Ireland (SIFI) in partnership with Local Authorities Ireland and is funded by IPB Insurance and the Department of Rural and Community Development http://www.socialinnovation.ie/social-enterprise-development/
- SSP and DLR LEO collaborating to explore Social Innovation supports
- Work is on-going with an individual social entrepreneur from our 'Introduction
 to Social Enterprise' courses who has expressed an interest in possibly
 exploring ideas around development of a local Social Enterprise Hub. 2
 potential sites in the Dún Laoghaire area are currently under consideration
 and it is hoped that, with continued support, this project will progress to
 implementation stage in 2019.
- Office space in Southside Partnership Blackrock has been identified as a
 potential 'Innovation Centre' to support groups, including Social Enterprises,
 and this is to be explored further and developed.



 A meeting was held in 2018 with the DLR LEO Manager to discuss possible collaborations on Social Enterprise including a 'Hub'

2018 Achievement for Objective 10 includes;

- Roll out of the national childcare schemes to all services on behalf of the DCYA continued
- The Learner Fund, a subsidised fund toward training childcare practitioners to level 5 or 6 was also provided, along with Learner Fund bursary for childcare practitioners who had completed recognised 3rd level courses. Capital grants, School-age Childcare grants, Parent & Toddler grants and Child-minder grants.
- Training delivered includes: Children First training to childcare practitioners,
 Equality & Diversity training under the Access and Inclusion Model (AIM)



- Continued to facilitate the Southside Childcare Action Network (SCAN) along with the Southside Partnership and Barnardos
- Equality & Diversity training provided under the Access and Inclusion Model (AIM), programmes designed to assist children with disabilities in the childcare setting. Update of website and distribution of information as necessary

Overview of Progress with Objective 10:

Good progress has been made with a focus on training and support for Childcare workers, and roll out of national policy requirements. However challenges remain, particularly with high costs of childcare and availability of carers in the County.




