## **Call for Musicians in Residence**

## Closing date: Monday 27<sup>th</sup> April at 12 noon

#### Introduction

Dún Laoghaire-Rathdown County Council Arts Office invites applications for Musicians in Residence.

There will be two residencies offered in 2017

The Musicians in Residence scheme is managed by Dún Laoghaire-Rathdown County Council Arts Office and is grant-aided by the Arts Council.

The Arts Office is open to applications from individuals or groups.

Applications are invited from musicians working in all musical genres and at all career stages.

Applicants (including all members of a group) must live, work, be originally from or have studied music in Dún Laoghaire-Rathdown.

The residencies are envisaged as part-time residencies specifically for the development, creation and showcasing of new work.

Each residency will offer a fee and 20 rehearsal days in dlr LexIcon's Studio (dates to be agreed at the start of the residency). Please note flexibility will be required around days and times available as the studio is a multi-disciplinary space. As part of the residency the musician/s must engage in three performances in the LexIcon Studio or other suitable venues in the county (dates to be agreed at the start of the residency).

#### **Budget information**

The fee, which is **to support the development and creation of new music** can range from €6,000 to €12,000. The amount should be based on whether the application is from a single musician or a group and also on the career stage of the musician/s. The fee is to be proposed by the applicant. A separate limited budget will be available and managed by dlr Arts Office for the promotion of the performances.

The successful musician/s will be required to provide Dún Laoghaire-Rathdown County Council with a tax clearance certificate prior to signing of contracts.

#### **Residency objectives**

The primary objective is

• To create opportunities for the musician/s to create and develop new work

Additional objectives are:

- To create opportunities for the musician/s to showcase new work
- To allow the public an opportunity to attend high quality musical performances.

#### **Programme of Work**

The details of the musicians in residence programme will be agreed in consultation with the appointed musicians. The programme will be supervised by an Assistant Arts Officer. In advance of the residency the following will be agreed:

- A programme of work focusing on the development and creation of new music;
- Clear goals, roles and responsibilities and agreed criteria for the Musicians in Residence and the Arts Office;
- The administrative support that will be provided by the Arts Office;
- Ongoing review and evaluation; regular meetings.

#### Site Visit

Musicians wishing to make a site visit to the LexIcon Studio will be accommodated on Thursday 13th of April at 6pm. Members of the dlr Arts Office will be available on the evening to answer any specific questions.

Site visits will not be accommodated outside this time.

#### **Selection process**

Applicants must submit a proposal together with details of previous work to date as follows:

- Typed proposal outlining artistic ideas and approaches (no more than three typed pages); this should include an outline of the benefits of the residency to her/his/their stage of development as a musician/s.
- Budget including proposed fee and other expenditure related to the creation of new work;

- A typed curriculum vitae (maximum 3 pages) including your connection to the Dún Laoghaire-Rathdown;
- Examples of previous work e.g CDS, sound files, etc that are PC/Microsoft Office compatible;
- Supplementary materials these may include reviews etc.

**Please note:** <u>Applicants must submit 4 copies of CV and proposal.</u> Only 1 copy of previous work and <u>supplementary materials is required.</u>

Please ensure that all submitted materials are clearly marked with the applicant's name. Please note that email applications will not be accepted. Late applications will not be accepted.

#### Insurance

The musician/s in residence agree to keep the Council fully indemnified against all claims howsoever arising and howsoever caused in respect of any damage, loss or injury of any kind or nature, whether arising directly or indirectly from the provision of the residency and to provide evidence of Public Liability insurance which indemnifies Dún Laoghaire-Rathdown County Council with a limit of indemnity of €6.5 million.

If the musician/s in residence employ other people to assist with the residency they must have Employer's Liability of €13 million which indemnifies Dún Laoghaire-Rathdown County Council. It is the responsibility of the musician/s in residence to ensure that other person(s) not employed by Dún Laoghaire-Rathdown County Council, but employed by the musician/s in residence to assist them

with the residency have adequate Public Liability (€6.5 million) cover which indemnifies both Dún Laoghaire-Rathdown County Council and the musician/s.

#### **Freedom of Information**

The provisions of the Freedom of Information Act 1997-2003 apply to Dún Laoghaire-Rathdown County Council. Applicants should state if any of the information supplied by them is confidential or sensitive and should not be disclosed to a request for information under the aforementioned Act. Applicants should state why they consider the information to be confidential or commercially sensitive.

#### Payments

The Musicians in Residence will be paid via the payroll system. They will not become employees of Dún Laoghaire-Rathdown County Council and are treated as employees solely for taxation purposes. Standard deductions will apply.

### **Background Information :**

#### dlr LexIcon Library, Dún Laoghaire

In autumn 2014 dlr LexIcon, the new Central Library & Cultural Centre opened to the public. This iconic public building is a crucial part of a programme of regeneration in Dún Laoghaire. It includes a
