





Public Sector Equality and Human Rights Duty

All public bodies in Ireland have responsibility to promote equality, prevent discrimination and protect the human rights of their employees, customers, services users, and everyone affected by their policies and plans. The Dún Laoghaire-Rathdown County Council Corporate Plan 2020 – 2024 sets a corporate goal to promote equality and human rights by implementing Public Sector Equality and Human Rights Duty.

DLR County Council continues to work towards eliminating discrimination, protecting human rights, and promoting equality, throughout our organisation and in the community.

The position of full time Equality Officer has been advertised and interviews will take place in May 2024, with appointment of suitable candidate thereafter. Once the Equality Officer is in place, we will develop a coherent strategy and action plan around the Public Sector Equality and Human Rights Duty. The role of the Equality Officer will be to ensure the structures are in place and will continually assess and review these processes. It is envisaged that the actions within the plan will be measurable, and update reports against the action plan will be included in the quarterly reports to council.

The Equality Officer will also take on the role of Access Officer and be the point of contact for the public and they will manage our engagement with the Disability Consultation Group. They will also support staff and line managers from an equality perspective. The Equality Officer will be involved in developing policies around supported recruitment and employment schemes and will work with HR and training to roll out Human Rights and Equality training for all staff.



Drainage & Flood Alleviation

Engineering and environmental consultants were appointed in December 2019 for Flood Risk Management Works on the Deansgrange Stream. Stages I and II of the project, namely Option Selection/Preliminary Design and Planning are now substantially completed. Public consultation for the Part 8 Planning process on the proposed scheme ended in August. The Chief Executive report for Part 8 was brought to, and approved at, the December Council Meeting, subject to approval from An Bord Pleanála (following an EIA determination direct request) and also a survey of SuDS opportunities being carried out in the wider catchment. An Bord Pleanála have now determined that no EIAR is required, and the project will now be brought to the Project Governance Board and the OPW for approval to proceed to Detailed Design. In the meantime, some small scale advance works and stakeholder engagement are being progressed and fee claim negotiations are underway.

Engineering and environmental consultants have also been appointed in 2020 for Flood Risk Management Works on the Carrickmines/Shanganagh Rivers. Preliminary design of a preferred option is completed. A Public Engagement Event took place on the 13th of December 2023. Comments, where appropriate, have been incorporated into the final option and the EIAR report can now be finalized once final environmental/ecological surveys are completed in June 2024. It is planned to submit planning documentation to An Bord Pleanala in Q3 2024.

The options for the Dodder Phase 3 FRS were recently presented to the Councillors in advance of a Public Consultation Day for the final options on the scheme. The PCD is due to occur at the end of May. The Monkstown environs flood risk mapping project is substantially completed, and final draft mapping has been submitted for review. Discussions are ongoing with the OPW mapping section re the preferred mapping format.

Finance

In 2021 the Council agreed to advance an additional loan facility of $\leq 17m$ to DLRP in respect of the fit-out of a proposed Grade A 13,471 sq. m. office development on the TC3 lands in Cherrywood, however the proposed development agreement did not proceed.

G2 one of the office blocks managed by DLRP is currently occupied by APC, a pharmaceutical research facility. APC are looking to expand their operations and have identified Cherrywood as their preferred location. The site beside their current facility is also owned by DLRP.

DLRP now wish to develop a 60,000 sq. ft. pharmaceutical research facility on site G3, prelet to APC on a 30- year lease and have negotiated very favourable heads of terms for a lease with APC. To develop the facility DLRP will require an additional loan of $\leq 17m$ from the Council.

There are several advantages to this request from the Council's perspective including: Secure APC as a tenant in Blocks G2 and G3 Creation of over 100 additional high-quality jobs in DLR Creation of a medical/pharma cluster in Cherrywood. Creates potential to secure principal repayment on existing loan facilities.

Agreement has been reached in principle to advance the additional loan facility to DLRP subject to the negotiation of a suitable loan agreement.

Tourism Development

Twinning Activities:

Building on the highly successful and active partnership with Vincennes, Paris, on April 23rd, An Cathaoirleach hosted a visit to County Hall by visiting students and teachers from Lycée Hector Berlioz, and by students from Stepaside Educate Together School. Xavier d'Argoeuves, Cultural Counsellor at the French Embassy in Ireland; Laura Le Cleach, Cooperation Attaché for French Language at the French Embassy; Tom Feeney of the Blackrock Business Association also addressed the students. This event formed part of a week-long exchange between the two schools.

Dublin Mountains Partnership.

Dun Laoghaire hosted the April meeting of the Dublin Mountains Partnership. Work is progressing on the development of the Dublin Mountains Festival, which will consist of a range of events taking place throughout the month of May.

POST Polycentric Tourism Strategy – Cognac, France Visit.

The 1st of the four cities in the strategy project hosted a strategy development meeting. Its purpose was to establish a collective understanding of the project to focus the four countries on a mutual set of strategic objectives for the project.

Cruise Staff training

The DLR Chamber and staff attended a training session to prepare them to welcome the summer of cruise guests into the town and county. Training focused on the needs of the guests and guiding them on their way while ensuring they are aware of the wealth of food/drink & shopping in the area.

Cruise Calls 2024

The first 3 cruise calls of 2024 arrived with over 5,000 passengers & over 2,000 crew in Dun Laoghaire Harbour. A team of welcome ambassadors dressed in green uniforms welcomed in the first calls with a brief to welcome, orientate and inform guests about what is on & how to get there.

Tourism Leading the Change – Meeting of all tourism authorities Meeting in Co Kildare.

The 1st event since Covid, the LGMA hosted a 2-day conference on April 18th & 19th for all Local Authority Tourism Officers nationally to inform the guests about innovation and sustainability in the tourism sector.

Enterprise Hub by Quarterdeck in the Ferry Terminal

The members agreed to a S183 leasehold disposal of the terminal building to Quarterdeck at the Council meeting held on 13 June 2022 to operate an Enterprise Hub. Quarterdeck had indicated that they expected to incur expenditure of c€4m and began the process of seeking tenders for the necessary works after the lease became effective in July 2022. Widespread tender price inflation meant that the tenders obtained by Quarterdeck came in significantly higher than expected, resulting in a delay to the commencement of the works as Quarterdeck sought to get the project to a position where it was financially viable, based on the short-term lease.

In the interim the following conditions of the lease have been satisfied:

- Work was completed on fit out of Stena Line Offices in April/May 2023.
- Work commenced on fit out of Ground Floor Offices in October 2023.
- Work commenced on fit out of Harbour Master Offices in November 2023.
- The Food Hall and Ground floor co-working area are currently under final design.
- The First Floor Co-Working Offices are expected to commence in and around April 2024.
- The Second Floor Co-Working Offices are expected to commence work in and around June 2024.
- The Event Space area and Co-working Offices on the ground floor are expected to commence work in September 2024.
- External signage and façade improvements to commence in the coming months.
- Car Park and Fencing works commence in May 2024.
- The New Quarterdeck Workspace Website and marketing plan/initiatives to be launched. A marketing campaign to be launched targeting interested parties who have requested office space and potential new tenants.
- A decision was made on the 30th April to grant the Fire Safety Certificate Application. The Economic Development Team will engage with Quarterdeck on the plan to open and occupy the building.
- The initial opening and launch of Quarterdeck Workspace are scheduled for May 2024.

Dún Laoghaire Harbour

Harbour General:

The sailing season has commenced with the majority of boats being lifted back into the water mid-April. Many water-sports businesses are gearing up for a busy season. The Harbour itself is seeing some commercial activity from Wind-farm survey vessels and some early bookings from a variety of other vessels with the improved berthing fenders on the Carlisle Pier.

Cruise Ship Business

The 2024 Cruise season is underway with 85 vessels currently booked into Dún Laoghaire Harbour. We are working with the Tourism Section, the Dún Laoghaire Business Association and the Dún Laoghaire Chamber of Commerce to maximize the local benefits of the cruise



visitors. The Economic Section is working on a town shuttle bus trial for the summer months in an effort to facilitate visitors in travelling into and around Dun Laoghaire Town.

Projects:

Harbour Masterplan

A project to create a Masterplan to guide the future development of the Harbour has been approved. Tenders for a design team were issued a consortium led by a Danish firm, Arrow Architects was the successful tenderer. The proposal includes significant public and stakeholder consultation and will likely commence in Q2/Q3 2024.

National Watersports Campus

DLRCC in partnership with Irish Sailing and the Irish Underwater Council have been approved in principle for Stream 1 Grant funding for the development of a National Watersports Campus. We have responded to requests for additional information and are now finalizing the grant process and agreements with the project partners. An MOU has been signed with Irish Sailing and Diving Ireland in order to set out and agree the objectives of the project.

A scheme to apply for additional "top-up" funding was announced in July and DLRCC have been successful in securing an additional \notin 410,952 for this important project. We are working to complete the grant contracts and tender documents and hope to tender for a design team in Q2 2024 to commence the Stream 1 design phase.

Dublin Array Windfarm

The developers of the Dublin Array Windfarm have approached the Harbour about the possibility of establishing an Operations and Maintenance Base for the windfarm. It is hoped that there might be synergies with the Ferry Terminal project. Early engagement is ongoing with the developer's team to establish the exact requirements.

Comhairle Contae County Council Community, Cultural Services & Parks

Community Integration Forum (formerly Community Response Forum)

The Ballyogan Regional Temporary Rest Centre opened its doors to Ukrainian nationals on 28th April 2022 and has a capacity to accommodate up to 392 displaced Ukrainian nationals. Up to 21st April 2024 over **11,327** people have stayed at the centre. Following the recent enactment of the Social Welfare and Civil Law (Miscellaneous Provisions) Bill 2024 Ballyogan has become a Dedicated Accommodation Centre (DAC) along with 5 other locations across the country and guests will be in Ballyogan DAC for maximum of 90 days. Among the facilities available in Ballyogan are separate laundry, sanitary facilities, internet access, television, chessboards, recreation room, translation services, computer classrooms as well as online access to Ukrainian newspapers and magazines.

As part of the comprehensive wrap around service, accommodation services at the Centre are being supported by HSE staff providing onsite support to meet the healthcare needs of Ukrainian residents, and residents also have access to an offsite GP service 7 days a week. English Classes and CV/Job Interview Preparation Classes are held in Ballyogan DAC every week by ETB and the Department of Social Protection are holding information sessions on life in Ireland for guests every week.

The Community response to the crisis in Ukraine and the influx of Ukrainian nationals into the county is being led and coordinated by Dún Laoghaire-Rathdown County Council in collaboration with a wide range of stakeholders through the Forum, supported by a wide range of community and volunteer groups.

The Forum has been meeting since 28 March 2022 and have met three times in April. Support services are being provided to those Ukrainian nationals who are being accommodated in Ballyogan and Larch Hill Scout Centre as well as in hotels and in private accommodation within the County. Support services are being provided to IPAs who are being accommodated in the county.

Local coordination efforts continue to provide comprehensive support services including from Southside Partnership dlr, HSE, An Garda Síochána, Department of Social Protection, D&DL Education and Training Board, TUSLA, Community and Family Resource Centres, dlr Volunteer Centre and a number of other community and voluntary groups.

Community Recognition Fund

Community Department continued to work with the successful applicants under the Community Recognition Fund to progress their projects. This fund launched by Minister for Rural and Community Development Heather Humphreys and Minister of State Joe O'Brien on 24th January 2023 is designed to specifically support communities that have welcomed and are hosting families and citizens from Ukraine and other countries CRF 2024 launched in March 2024 with €765,487 allocated to Dún Laoghaire-Rathdown for capital projects. This fund is aimed at those areas which have the highest level of new arrivals and where a clear need for investment is identified.

Dún Laoghaire-Rathdown Local Economic and Community Plan 2023-28

The Dún Laoghaire-Rathdown Local Economic and Community Plan for 2023-2028 has been developed to guide the sustainable economic and community development of the County over the next five years. The LECP 2023-28 was adopted at the County Council meeting held on 8th April 2024.

Community and Volunteer Awards

The Dún Laoghaire-Rathdown Community and Volunteer Awards took place in the Talbot Hotel, Stillorgan on 24th April 2024. The Awards provided an opportunity for the Council to



recognise and celebrate the large number of people and projects across our county, all contributing to make this county a vibrant place to live.

The awards were presented by An Cathaoirleach of Dún Laoghaire-Rathdown County Council, Cllr Denis O'Callaghan and Therese Langan, Director of Services, Community and Cultural Development in dlr.

This year 61 community groups and 54 volunteers were formally acknowledged for the valuable contributions they make to their communities. Awards were made to Community Groups and Volunteers to recognise and celebrate their positive contributions across the county promoting a wealth of community development activities including child and youth development, age friendly, arts and culture, environment and climate action, inclusion and integration, health and wellbeing, disability and neurodiversity and civic pride.

Comhairle na nÓg

DLR Comhairle na nÓg representatives gave a presentation to the Elected Members at the April Council Meeting, updating members on their work regarding their work topic for this year, School Stress. The feedback and advice received from Elected Members has been greatly appreciated and has been fed back to all the members of DLR Comhairle for discussion and consideration. The Committee and members of DLR Comhairle continue to progress their work topic during April.

Local Policing Fora (LPF)

A meeting of the Central Dún Laoghaire LPF took place on 9th April 2024. A meeting of the Loughlinstown Ballybrack Shankill LPF took place on 16th April 2024.

Launch of dlr High Security Locks Scheme 2024

The scheme was launched during March for applications from homeowners 65 years of age and over living in dlr to replace existing lock barrels or cylinders in external doors with high security anti-snap locks. Applications will only be considered from owner occupiers of privately-owned homes who reside in the county and will cover the total cost for the replacement of lock barrels only, on up to maximum 2 locks per home – front door / back door / side door. Closing date for applications: 31st May 2024 and link to online applications <u>HERE</u> and hardcopies & more information available from the Community Section, dlr County Council at 01 205 4893 / <u>community@dlrcoco.ie</u> 102 applications received to date with a large volume of calls requesting hardcopy application forms on an ongoing basis.

dlr Older People's Council

The dlr Older People's Council (OPC) held their monthly meeting on the 16th of April and updates were given on planned OPC social events for Autumn 2024; current <u>Transport Grants</u> available from the OPC have been increased to €300 per member group. Updates provided on attendance at local and national meetings and events by the dlr OPC members.

Domestic Violence Refuge

The Council commissioned a Domestic Violence Refuge Needs Assessment to establish if there was a need to provide a Domestic Violence (DV) refuge within the County. The report established an evidence-based approach that underpins the need for a refuge in the Dun Laoghaire Rathdown area.

The Council is progressing this project under the Planning and Development Acts and the regulations made thereunder and more specifically the Planning and Development (Section 179A) Regulations 2023.

This project will deliver 12 units of accommodation and associated facilities to accommodate those affected by domestic abuse and their families.



Arts

Municipal Gallery, dlr LexIcon Programme

Fruity Bodies, an exhibition of new and recent work by Joanna Hopkins, continues in the Gallery. It explores folklore with landscape and the human form. Hopkins uses plants and plant dyes from her local hedgerows and fields in a wide range of media including sculpture, embroidery, photography and film. Joanna Hopkins is an Irish artist working in video, collage, drawing, photography and installation. She has exhibited across Ireland, the UK, Europe, China and the US.

Shanganagh Park House Childcare Commission

Artist Helen Barry has been working in Shanganagh Park House Community Childcare Service for the past six months, co-creating new artwork with the children and early years educators. Caregivers and children from the PEEP+Shanganagh Programme also worked with Helen. The new work will be exhibited as part of the upcoming 'Room to Explore exhibition for 0-5 year olds' opening on May 18 in the Gallery, dlr Lexicon. This opportunity was supported by dlr CYPSC and is the third commission for children and young people funded the Creative Ireland funding for Cruinniú na nÓg, the National Day of Creativity for Children and Young People.

Artist Residencies at Centre Culturel Irlandais announced

Cecilia Bullo and Sal Stapleton are awarded artist residencies in partnership with the Centre Culturel Irlandais, Paris. Cecilia and Sal were selected from 69 dlr submissions, the highest number of applications received for this unique opportunity.

Justine Doswell announced as UCD Trapdoor Dance Artist in Residence 2024 In

partnership with UCD College of Arts and Humanities, Justine Doswell is the first-ever UCD Trapdoor Dance Artist in Residence. Dance artist, choreographer and creative producer, Justine Doswell has worked with numerous notable Irish and international choreographers, directors and companies. Established through partnership, and awarded through an open call, this residency will support Justine to connect with UCD's Creative Futures Academy and utilise both Council and UCD facilities, including the new state-of-the-art performance theatre Trapdoor and dlr LexIcon to test and develop concepts and materials.

- **LOTE:** online database of digital books in World Languages, created for children to enjoy books and learn language through storytelling. The platform provides over 1,600+ digital books in 50+ languages together with English translations.
- **Medici.tv:** video streaming service in classical music, opera, dance, and jazz. There are thousands of videos of concerts, operas, ballets and masterclasses, as well as weekly and monthly live concerts and all that is required is a dlr Library Card.

Library staff in dlr LexIcon keep in contact with the staff and service users of the International Protection Centre in the Eblana Centre (Dún Laoghaire) to let them know of the services and resources available to them in their local dlr library. Book stock has been sent to the service users of the IPCs in Dundrum and Dún Laoghaire. In the LexIcon, a meeting space with free wifi has been made available, and tutors from the *English in the Library* group offer weekly English conversational sessions for Eblana centre users.

April Highlights

In recent months, dlr Libraries have been working on enhancing and expanding our services, for existing as well as potential new users:

Increased Opening Hours

From March 2024, our library spaces are open an additional 42 staffed hours on a weekly basis, making a total of 475.5 hours open to the public per week – 376 staffed hours and 99.5 self-service hours. These revised opening hours include 9.30am opening and lunchtime opening across most of the week, plus the introduction of Monday night opening until 8pm in 2 additional branches – Deansgrange and Dundrum Libraries.

Library Website Upgrade

In April 2024, we launched an upgrade to our existing website, which mirrors the main dlr Council website in terms of layout and accessibility features. This upgrade allows us to quickly update information on our services and resources; from our book collections to our sensory toys and equipment, from the latest branch news to details of our events programme, not forgetting our expanding collection of online material. We also include designated pages for information on local and national initiatives that library staff are involved in such as the Right to Read Literacy Campaign, Healthy Ireland at your Library and Age-Friendly Libraries.

Study Spaces Pilot: dlr LexIcon

On 15 April, dlr LexIcon began trialling a study spaces online booking system. The pilot will run until 15 June 2024. dlr LexIcon has 141 study spaces across Levels 4 & 5, and the booking system will allow for more transparent and more equitable usage of these spaces. Spaces are available to book during library opening hours (Mon-Saturday) and divided into 3 sessions of 3.5 hours across each day. Students may book up to 6 sessions per week. Please see our website or contact staff in dlr LexIcon for further details.

One Dublin, One Book Event: The Role of the Sea in Contemporary Irish Literature (Thurs 25 April, dlr LexIcon)

As part of the One Dublin, One Book programme of events for 2024, Louise Nealon, author of *Snowflake*, this year's choice for One Dublin, One Book was joined in conversation by Sheila Armstrong, Olivia Fitzsimons and Aingeala Flannery. In front of a sold-out audience, they discussed the role of the sea in their lives, both on and off the page, their literary influences and more.



Reading Eavan: A Tribute to the Poet Eavan Boland (Thurs 25 April, dlr LexIcon) As part of **Poetry Day Ireland** 2024, dlr Libraries hosted this event to celebrate the life and work of poet Eavan Boland, who died in 2020. There was huge interest in the event, and the audience of 75 were joined by a selection of invited readers, who shared their favourite Eavan Boland poems and spoke of their connections with her. There was also musical accompaniment, contributing to what was a friendly and inclusive evening to commemorate the beloved poet.

Authors for Schools Programme

This recent initiative is aimed at local primary schools. Over the coming months, we will welcome the best Irish authors of children's books to our Libraries to engage with classes from local primary schools. In April, we welcomed Marita Conlon McKenna and Natasha Mac a'Bháird to dlr LexIcon, Alan Nolan to Deansgrange, and Brian Gallagher to St. Anne's National School, Shankill.

Sensory programming for the Neurodiverse

Autism Awareness month

April is Autism Awareness month and dlr Libraries were delighted to take the opportunity to showcase our Accessible Services Collection by holding Drop-In Information Sessions in Dalkey and Dundrum Libraries. dlr Libraries' Accessible Services Collection includes sensory/tactile toys, equipment and tools to help build motor skills and other items that may help develop life skills. As part of our commitment to supporting neurodiverse communities, this collection is one element of our accessible services which include Social Stories for each library, quiet evenings in many branches as well as events tailored to neurodiverse audiences. Staff members brought a selection from the collection to each branch and spoke with interested members of the public. These information sessions will continue during May.

Studio Saturday (6 April, dlr LexIcon)

Our neurodivergent Studio Saturdays are monthly workshops/events tailored to children with additional needs/neurodivergence. For April we were delighted to be joined again by Karen Anderson of SENSEable Kids for a sensory play experience. This session involved erupting volcanoes and sensory bins, play prompts and sensory toys, and was hugely popular as ever.

Sensory resources from dlr Libraries

- Our Tovertafels (Magic Tables) in dlr LexIcon, Deansgrange and Dalkey Libraries are available to book by individuals and groups
- Sensory Room in Deansgrange Library is available to book
- Items from our Accessible Services Collection [ASC] of sensory toys and equipment can be borrowed
- We continue with designated *Quiet Evenings* in many library spaces where lighting is dimmed, and phones and IT equipment are silenced to make our spaces more welcoming for the neurodiverse
- Each library has a sensory box with a selection of toys/equipment including ear defenders. These items can be used onsite by visitors to the library

Events for Adults

Active Movement for Adults with Active Academy (2, 9, 16, 23 & 30 April, dlr LexIcon) As part of our Healthy Ireland at Your Library programme, we were delighted to be partnering again with Lisa from Active Academy for these Active Age classes. These are functional fitness classes designed to help with everyday life and suitable for older adults of all abilities. The



original class (25 spaces) booked out quickly and we were able to fill another later class almost immediately. Feedback from participants has been hugely positive, with many requests for more classes with Lisa.

Arts & Crafts Workshops

Spring Crafts @ dlr LexIcon (Throughout April, dlr LexIcon)

dlr LexIcon held a series of craft workshops for adults throughout the month of April. All held on Thursdays, participants had the opportunity to learn Needlefelting and Coiled Basketry with Sharon Wells, Intermediate Book Binding with Nicola Faull, Drawing with Nicola Sedgewick and were introduced to Watercolours with Fiona Ní Ghliasáin, as well as Leather Jewellery Making with Mary Daugherty and creating Wire and Crystal Trees with Susie Kenny.

Visible mending workshops with Pauline Gallagher (19 & 26 April, dlr LexIcon)

Visible mending is a design-led decorative mending approach. Over four Friday mornings, Pauline is teaching hand stitching visible mending techniques; slow stitching practices which will allow you to slow down, relax, reconnect with old traditions and enter a mindful/meditative state as you focus on the stitching.

Spring Art Workshop with Kim Jenkinson (23 April, Dalkey Library)

Artist Kim Jenkinson facilitated this Spring-themed art workshop where participants learned to create magnolia blossom branches, using crepe paper to create the blossoms and attaching to gathered branches and twigs with a mix of wire and florist tape.

dlr Social Prescribing Programme for Health and Well-being

We continued to host workshops in collaboration with Southside Partnership and supported by the Creative Ireland Programme. Due to popular demand, a second 6-week *Get into the Flow* nature art course began on 8 April in dlr LexIcon, facilitated by artist Joyce Fitzpatrick.

dlr Yarnspinners Storytelling Circle (17 April, dlr LexIcon)

This month we were delighted to welcome guest storyteller and writer Simone Schuemmelfeder. Born close to the "Fairy Tale Road" in Germany which connects the locations of many tales the Brothers Grimm collected, Simone grew up surrounded by stories. She has performed extensively across Ireland and abroad in schools and libraries, at festivals and for various institutions. Her shows are a refreshing blend of the old and the new, with folktales and modern stories, bridging generations and cultures to touch the listener's heart with the oldest of all arts. Yarnspinners meets on the 3rd Wednesday of each month with the final meeting of this series on Wednesday 19 June.

Film Clubs (18 April, Blackrock Library, 18 April, dlr LexIcon)

Held once a month, the Blackrock Film Club offers the screening of a cinematic classic or undiscovered gem every 3rd Thursday, followed by a group discussion. This month's screening was the American film *A Ghost Story* (2017), directed by David Lowery.

For Spring and Summer, the dlr LexIcon Film Club will be holding free screenings of an eclectic selection of World Cinema. April's film choice was *The Crying Game* (1992) directed by Neil Jordan.

Weekly computer classes with Age Action continued in Blackrock Library with twice weekly classes in Deansgrange Library.

Library Clubs & Groups for adults

A wide variety of clubs and groups continue meet in our library spaces. These include the Language Exchanges and the Scrabble Club in Deansgrange Library, Scrabble Club in Dundrum, the Craft Circle in Shankill Library and Craft and Chat in dlr LexIcon, the Knit Clubs in Cabinteely and Blackrock Libraries, and the Family Lego Club in Blackrock Library. The English in the Library group meet weekly in dlr LexIcon. Blackrock Library hosts a Local History Group every month and the Musical Memories Choir, for those affected by dementia plus their family carers, takes place every Thursday morning in Deansgrange Library, and is run in conjunction with Newpark Academy of Music.

Book Clubs

Exhibition Programme

PPAI Press Photographer of the Year Award Exhibition 2024 (11 March – Tues 9 April, dlr LexIcon)

The exhibition was officially launched by An Cathoirleach Cllr Denis O'Callaghan and David Branigan President of The Press Photographers Association of Ireland on Wednesday 27 March. Now in its 46th year the PPAI, AIB Press Photographer of the Year Award, celebrates the very best of Irish press photography. The exhibition features over 100 winning and highly commended photographs covering Irish life, at home and abroad during 2023, and highlights the dedication and skill of Ireland's top press photographers.

A Portrait in Flesh: My life with Bowie - A Photographic Exhibition by Denis O'Regan (15 March - 10 April, dlr LexIcon)

A career retrospective by Bowie's official photographer Denis O'Regan, an English photographer whose imagery is particularly associated with the punk movement, Queen, David Bowie, Duran Duran, and many more rock n roll luminaries. O'Regan has photographed everyone from AC/DC to ZZ Top, documenting Punk, New Romanticism, Grunge, and Heavy Metal along the way. He has travelled as official photographer to David Bowie, The Rolling Stones, The Who, Queen and many more. His work has been widely published and exhibited and has photographed David Bowie more than any other photographer, covering over 200 concerts around the world.

Local Colour by artist Shabnam Vashist (4-30 April, Deansgrange Library)

Indian-born designer, visual artist and author, **Shabnam Vasisht** sees colour as her cultural inheritance and expresses emotion through it. Sustainability is an important factor in Vasisht's art practice. A retired dress-designer living in Ireland for over 45 years, she often uses the



medium of her trade to create two-dimensional images and soft sculptures.
