Providing services, support and information for migrants, asylum seekers and refugees.

In addition to outreach and information offered around the country, IOM Ireland have opened in 2020 the country's first Migrant Resource Hub. The Migrant Resource Hub aims to provide a space in which migrants, asylum seekers and refugees can connect in a welcoming environment, as well as gain information and insight on migration-related issues.

The Hub will also offer consultation services with experienced professionals from right across the migration spectrum, not only in Ireland, but in countries of origin also through virtual collaboration. It will operate as an open and friendly collaboration and training space, where individual migrants, diaspora communities, civil society and governmental agencies can build positively on themes that affect them.

In addition, the Hub will also act as a counselling centre where migrants can avail of services directly, such as AVRR.

The Migrant Resource Hub will be open to the public from 10:00-16:00 Monday-Friday, except public and/or IOM public hol.



Who Are IOM?

Established in 1951, the International Organization for Migration is the leading inter-governmental organization in the field of migration and works closely with governmental, intergovernmental and non-governmental partners. IOM has always worked closely with the United Nations and in 2016 IOM became part of the UN family. With 173 member states, a further 8 states holding observer status and offices in over 100 countries, IOM is dedicated to promoting humane and orderly migration for the benefit of all. It does so by providing services and advice to governments and migrants. Member states recognise IOM as the global lead agency on migration and IOM advocates for migrants and their rights worldwide.

As the United Nations Migration Agency, IOM works to help ensure the orderly and humane management of migration, to promote international cooperation on migration issues, to assist in the search for practical solutions to migration problems and to provide humanitarian assistance to migrants in need, including refugees and internally displaced people. The IOM Constitution recognizes the link between migration and economic, social and cultural development, as well as to the right of freedom of movement.

IOM works in the four broad areas of migration management:

Migration and development Facilitating migration Regulating migration Forced migration.

IOM activities that cut across these areas include the promotion of international migration law, policy development, protection of migrants' rights, migration health and the gender dimension of migration.

What Does IOM do in Ireland?

The International Organization for Migration (IOM) opened an office in Ireland in 2001. Ireland became a full member government of IOM in 2002. IOM Ireland works to help ensure the orderly and humane management of migration, to promote international cooperation on migration issues, to assist in the search for practical solutions to migration problems and to provide humanitarian assistance to migrants in need, including refugees and internally displaced people.

Although IOM Ireland is heavily involved in numerous migrant focused projects, IOM Ireland currently implements four core programmes in Ireland and these are:

Counter Trafficking - Geared towards the prevention of trafficking in persons, particularly women & children and the protection of migrant rights.

Family Reunification - IOM assists in organising the travel arrangements for family members of recognised refugees to come to Ireland, once the Irish Government has issued the necessary visas.

Resettlement - IOM Ireland acts as the key liaison between the Irish Government, and IOM Missions in both host, and transit countries, at all stages of the resettlement process, from initial budgeting, through documentation, logistical arrangements, and travel itself.

Assisted Voluntary Return & Reintegration -

AVRR is an indispensable part of a comprehensive approach to migration management aiming at orderly and humane return and reintegration of migrants who are unable or unwilling to remain in host countries and wish to return voluntarily to their countries of origin.

The United Nations High Commission for Refugees (UNHCR) has had a continuous presence in Ireland since 1998. We work with the Irish government, officials, NGOs and other partners to protect people forced to flee their homes and support them to live their lives with dignity and respect.

At UNHCR, we seek to uphold the basic human rights of uprooted or stateless people in their countries of asylum or habitual residence, ensuring that refugees will not be returned involuntarily to a country where they could face persecution.

Nasc, the Irish word for 'link', empowers migrants to realise and fulfil their rights. Nasc works with migrants and refugees to advocate and lead for change within Ireland's immigration and protection systems, to ensure fairness, access to justice and the protection of human rights. Our goal is to realise the rights of all migrants and refugees within Irish society.

Nasc operates a walk-in service four days each week (seven sessions). We provide information and advice on a range of immigration and asylum-related issues. The service is free, non-judgemental and confidential. We can see up to five people at each session. The walk-in service is offered on a first-come, first-served basis.

Spirasi (Spiritan Asylum Services Initiative) is the national centre for the rehabilitation of victims of torture in Ireland.

The rehabilitative services offered by Spirasi are unique in Ireland and consist of the following:

- multidisciplinary (medical, therapeutic and psychosocial) Initial Assessment (IA) for both victims of torture and those who have suffered cruel and inhuman or degrading treatment;
- ongoing therapeutic interventions for victims of torture which includes individual, group and family therapies;
- both in-house and outreach psychosocial supports;
- Medical Legal Reports (MLRs) for the protection process;
- English language classes for victims of torture and their families that complement the rehabilitative work.


