SECTION 75 OF THE ROADS ACT, 1993 TEMPORARY CLOSURE OF THE ROADS WITHIN THE SANDYFORD BUSINESS DISTRICT TO FACILITATE THE SANDYFORD 5K

Dún Laoghaire-Rathdown County Council has received an application from Dundrum South Dublin Athletic Club, in association with Sandyford Business District Association, for partial to full closure of a number of roads within Sandyford Business District on **Thursday, 8th May 2025**, to facilitate the 2025 Sandyford 5K.

The Start Time of the Race is 7:30 p.m.

It is envisaged that the roads will be closed at 6:30 p.m. and will remain closed until after the completion of the race at 8:30 p.m.

The Roads affected are as follows:

1. Blackthorn Road (Partial)

4. Carmanhall Road (from Dunnes Car Park to Blackthorn Road)
