# SECTION 75 OF THE ROADS ACT, 1993 TEMPORARY CLOSURE OF GLENAMUCK ROAD, CARRICKMINES

Dún Laoghaire-Rathdown County Council has received an application from BAM Civil Limited that proposes the temporary closure of Glenamuck Road, Carrickmines from its junction with Brambledown housing estate to its junction with Enniskerry Road (Golden Ball T-junction) from **Friday, 30<sup>th</sup> May 2025**.

Finishing works will take place at Baker's Corner junction and impact traffic flows along all approaches - Kill Avenue, Kill Lane, Abbey Road, Rochestown Avenue until Friday, 16<sup>th</sup> May 2025.
